Dr. Normandia presented Personnel Teaching Items (a) through (d).

Mr. Sangiovanni explained that because of the number of students on the swim team with one coach, no assistant coach and no medical staff, the Board should reconsider this and approve an assistant coach at both high schools.

Mr. Eremita was in agreement with Mr. Sangiovanni. He said, as he has in the past, that the Board look at other programs where there are 3-4 coaching staff members with less than 50 participants. This should be looked into at both high school and middle school levels. Track programs should be considered at the middle school level. We need to begin moving in those directions. Dr. Normandia and Mr. Gialanella have begun reviewing re-apportioning and rethinking that schedule.

Mr. Eremita asked that by the November 7 Board Meeting an investigation be done as to whether assistant coaches are needed at both high schools. Mr. Gialanella will know in the next few days what the number of participants will be.
