Mr. Woska updated the Board on construction projects. Continuing operations at both athletic fields. Osbornville School - Steel columns have been set; masonry brick walls are going up within the week.

Auxiliary items were reviewed.

Mr. Richard Williamson, audience, asked what the future would be now that enrollment is over 11,000 students. Dr. Normandia said we are in year three of the five-year demographic study and the district is right on target. The district needs stabilization. A new demographic study will soon need to be done.
