FOR BOARD APPROVAL JUNE 11, 1998

T & M Assoc. **WHEREAS**, there exists a need for a Civil Engineer for both H.S. fieldhigh school field renovations and reconstruction, and

WHEREAS, FUNDS ARE AVAILABLE FOR THIS PURPOSE, AND

WHEREAS, the Local Public Contracts Law (N.J.S.A. 40A:11-1 et seq.) requires that the Resolution authorizing the award of contracts for "Professional Services" without competitive bids must be publicly advertised

NOW, THEREFORE, BE IT RESOLVED by the Brick Township Board of Education, the Township of Brick, as follows:

1. That T & M Associates be and is hereby appointed by the Brick Township Board of Education to said position.
2. This appointment is made without competitive bidding as a "Professional Service" under the provisions of the Local Public Contract Law because the services are to be performed by a recognized profession licensed and regulated by law.
3. The cost shall not exceed \$90,000 for all services, including surveys.
4. A copy of this Resolution shall be published in the Ocean County Times Observer and the Asbury Park Press as required by law within ten days after its passage.
