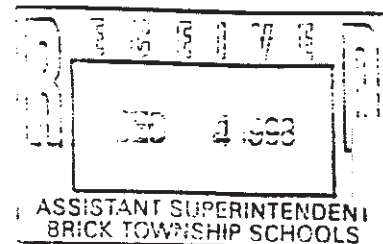

RESOLUTION

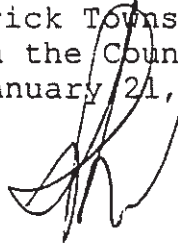
WHEREAS, Senate Bill 851 was signed into law on June 30, 1998; and

AGREEMENT

This Agreement made between the Brick Township Board of Education and the Transport Workers Union Local 225 Branch 4 stipulate to the following:

1. All TWU bargaining unit members who have accumulated up to one year of vacation time will be permitted and required to use the accumulated vacation time prior to June 30, 1999. Any carry-over vacation day requests post June 30, 1999 must be approved prior to June 30, 1999 by the School Board Administrator/Board Secretary, and/or his designee.
2. An employee who has more than one year of vacation time, which is not permitted pursuant to the Agreement between the parties, will not be permitted to take this accumulated time and will lose this time.
3. The parties agree there will be no grievances, arbitration and/or any other actions as a result of this action.
4. The parties acknowledge this Agreement extends the vacation day benefit beyond the terms of the labor Agreement and that this is a one-time accommodation to resolve this matter. It is also understood that this Agreement does not abridge the wording in Article IV, B. 1. of the collective bargaining Agreement, and the banked days for those employees hired prior to vacation accrual being awarded up front.
5. The parties agree this Agreement does not, and will not establish a precedent and/or past practice.
6. Vacation time used in the calendar year 7/1/98 to 6/30/99 shall be deducted from the accrued time first before the current time is deducted.
