Dr. Normandia presented Policy Item (a). He gave some background information regarding the policies being presented tonight for first reading. About one year ago the State of New Jersey, in its special education code and implementation of that code, is in non-compliance with the Federal Government. The auspices under which we have been working under the guidance of the County Superintendent and the Department of Education in terms of administering our special education programs has been wrong as far as the Federal Government is concerned. To give evidence to that, the 25 large districts had to be monitored and had to fail monitoring so these changes could be produced. The Boards of Education had to adopt law. We have never had to adopt law before as Board policy. In this case, with special education they are requiring we adopt the law before we are monitored again. The large 25 school districts will be monitored now, again, to see if New Jersey is moving on that compliance with Federal code.

Dr. Boyan did not have copies of the Statutes referenced to in the policies and he was taking it on face value. Mr. Montenegro has reviewed the policies as well as the proposed regulations and it echoes the Regulations found in the Administrative Code Title 6A and Title 18A. The citations are correct.
