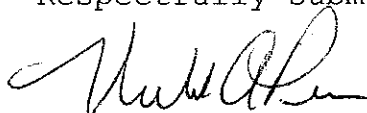
(d) Move the Board of Education **accept** the **resignation** of **Dr. James Dwyer** as Special Assistant to the Superintendent effective August 10th, 2007.
