Upon my arrival I spoke with the caller, Mr. Farha Sharifipour, who is the owner and property manager of the apartments located at 140 West Fort Lee Road Bogota, NJ 07603. Ms. Sharifipour reported the male party in a U-Haul truck was parked in multiple parking spaces and when asked his business there, the male party became irate and used racial slurs towards Mr. Sharifipour. I approached the driver of the U-Haul truck, identified as Mr. Neil McKenzie DOB: [REDACTED] residing at 24 Washington Place Teaneck, NJ 07666. Mr. McKenzie reported he was waiting for his brother to arrive, who resides at 140 West Fort Lee Road. While speaking with Mr. McKenzie, he appeared to be under the influence of narcotics and/or alcohol. I asked Mr. McKenzie numerous times if he was ok to which he replied with a different answer each time. I asked Mr. McKenzie for identification and he reported he did not have any identification on him. I gathered his information and attempted to request a computer check be conducted by dispatch. Prior to being able to do so, Mr. McKenzie began reaching into the vehicle for an unknown object. I advised Mr. McKenzie to remain outside the vehicle and he failed to comply with all verbal commands. At that time, Mr. McKenzie was placed in handcuffs for his safety and mine. A computer check was conducted on Mr. McKenzie which yielded an active ACS warrant 0260-W-2022-000065 issued by Teaneck Municipal Court. Mr. McKenzie was searched and placed in the rear of radio car 43 for transportation to headquarters. Once in headquarters, Mr. McKenzie was placed in the holding cell and searched. All his property was gathered and inventoried. Teaneck Police advised they will be releasing Mr. McKenzie on his own recognizance and will be faxing a form to sign. Mr. McKenzie signed the form, was issued a copy, returned his property and released.

11/18/2024 20:35	On November 18th, 2024, I was dispatched to 137 Maplewood Avenue at approximately 1944hrs for a fight. Upon arrival, I met with Mr. Kevin Rodriguez who stated a large group of people were fighting in front of E. Roy Bixby School, specifically near the intersection of Maplewood Avenue and Fischer Avenue. Sergeant Geraghty #103 was also dispatched. While speaking to Mr. Rodriguez outside of the residence, he noticed his fence was damaged due to the fight that had occurred prior to police arrival. It should be noted, I observed the damaged fence while on scene. While speaking to Mr. Rodriguez, his sister, Ms. Kaydee Rodriguez came outside and stated she observed the incident and called the police. Ms. Rodriguez stated she was in her room when she heard a loud noise. Ms. Rodriguez further stated she observed two vehicles parked with the engine running on Maplewood Avenue. She further stated approximately ten young adults were "scattered" in the area fighting. Ms. Rodriguez stated she observed an individual with a bat, but she did not see him swing the bat. Ms. Rodriguez related the two girls on scene were telling the boys that were fighting to get off each other. She observed a male with long dreads punch another individual on scene. Ms. Rodriguez stated the incident lasted approximately ten to fifteen minutes and the individuals left the immediate area in the two vehicles. One vehicle fled towards Queen Anne Road and the second vehicle made a right on Fischer Avenue. While canvassing the immediate area, Mr. Rodriguez pointed out a small glass jar containing a green leafy substance labeled "Banana Koko". I took possession of the glass jar and transported it to police headquarters. It should be noted, Ms. Rodriguez filled out an affidavit on scene. I canvassed the immediate area for possible involved individuals and video surveillance which both yielded negative results at this time. E. Roy Bixby school has exterior cameras that may have captured the incident. I advised Ms. Rodriguez we would follow up with the school to obtain video footage. The information was forwarded to the detective bureau for further investigation. The glass jar was tagged and placed in the evidence locker located in police headquarters. My BWC was activated and captured the incident.
