On July 3, 2024 at approximately 2351 Hours, P.O. O'Donnell #107 and I were dispatched to 178 Linwood Avenue (intersection of Palisade Avenue and Linwood Avenue) for a motor vehicle accident hit and run with injuries. Upon arrival, I observed a Silver Toyota Rav 4, bearing NJ registration P23UAK stationary on the Northbound lane, facing South with its hazard lights on. I was met with three people on scene. The driver, Mr. Edwin Hidalgo, the rear passenger, Ms. Yaely Aguilar, and a witness to the accident, Mr. Jimmy Guierrez-Mendoza.

Ms. Aguilar seemed to be shaking and complaining of pain in her right arm. I was able to assist her to a safe location to await for Basic Life Support Units. I advised dispatch to send an ambulance and Holy Name Medical Center Basic Life Support arrived on scene to tend for her care.

Mr. Hidalgo complained of pain in his right leg, so I called for a secondary Holy Name Medical Center Ambulance which arrived on scene to tend for his care. While both parties were being treated on scene, I was able to communicate with Mr. Guierrez-Mendoza, who stated that he witnessed the accident. Mr. Guierrez-Mendoza stated that he saw Mr. Hidalgo's vehicle traveling West on Linwood Avenue and then turning South onto Palisade Avenue. It was at that time, Mr. Guierrez-Mendoza witnessed a Black Ford Explorer driving South at what he described as an extremely high rate of speed, which caused the motor vehicle accident. Mr. Guierrez-Mendoza stated that after the motor vehicle crash, the driver of the striking turned East onto Elmwood Avenue.

At this time I was able to provide a description of the vehicle to Sgt. Rivera #99, and P.O. O'Donnell #107 over the air. Headquarters put out a SPEN message with the vehicle description, and P.O. O'Donnell was able to locate the vehicle at the intersection of Linwood Avenue and Dunn Avenue shortly after.

Another witness came to the scene of the accident, he was later identified as Mr. Sergio Lopez. Mr. Lopez stated that he was notified of the accident by Ms. Aguilar. Mr. Lopez stated he was on the phone with Ms. Aguilar outside of his residence on Elmwood Avenue, when he heard a vehicle that sounded like it had a flat tire come to a stop in front of his home. Mr. Lopez was able to attain the license plate number from the damaged vehicle stopped in front of his home. The registration he provided was a match for the description given as the striking vehicle.

Both Mr. Hidalgo, and Ms. Aguilar signed refusal for further medical attention at this time. A & D Towing arrived on scene and towed both vehicles. I then provided Mr. Hidalgo a courtesy transport to Valley Bank in our Borough without incident, and his wife picked him up from that location.

I came into police headquarters and inventoried Ms. Schneeloch's property. I also completed a NJ-TR1 for the motor vehicle crash.

On Thursday, 7/4/24, as I was conducting a follow up, I was able to attain surveillance footage of the accident. It was forwarded to P.O. O'Donnell and the Detective Bureau respectively.

My body worn camera was active for this incident. NFPA.

Note

On Wednesday, July 4, 2024, at approximately 2351 hours, Officer Kalachian #110 and I were dispatched to 178 Palisade Avenue for a report of a hit and run motor vehicle accident with injuries. Upon arrival, Officer Kalachian made contact with the caller Mr. Edwin Hidalgo, who was also the driver of the vehicle that was struck. He explained, he was stopped at the intersection of Linwood Avenue and Palisade Avenue and proceeded to make a left turn onto Palisade Avenue. While making the turn a Black SUV traveling South struck his vehicle and subsequently fled the scene. An ambulance was requested to the scene. Ms. Yaely Aguilar, the passenger and Mr. Hidalgo were treated on scene and signed a refusal for further medical treatment.

I was then able to canvass the area in an attempt to locate the striking vehicle. While canvassing the area Officer Kalachian advised me of the striking vehicle description which was a Black Ford Explorer with substantial front driver's side damage. At the intersection of Linwood Avenue and Dunn Avenue, I observed two female parties appearing to examine the exterior of a Black Ford Explorer. When I approached the vehicle the two female parties began to walk away from it and began walking East. I examined the vehicle and observed substantial damage to the front driver's side of the vehicle matching the damage described by Officer Kalachian.

I then stopped the two female parties, later identified as Ms. Dallas Schneeloch and Ms. Daphne Fancher. I requested for an additional officer to my location for further investigation. While speaking with both parties, I could smell a strong odor of alcoholic beverage. I asked both parties where they resided, to which they responded "Elmwood Park" and "Midland Park" respectively. Sgt. Rivera then arrived on scene and a motor vehicle check was conducted on New Jersey registration T91RSW. The check showed a Ms. Rachael Schneeloch as the registered owner residing at 156 Bank Street, Midland Park New Jersey.

While speaking, Ms. Dallas Schneeloch and Ms. Fancher were uncooperative and refusing to answer questions in regards to the vehicle. Both parties were placed in two separate patrol vehicles for further investigation. While attempting to gather Ms. Schneeloch's name and date of birth, she provided me with a name of Dallas Banuelos and a date of birth of [REDACTED]. While speaking to her she stated that she did not have her driver's license in her possession and that she knew nothing about the damaged vehicle.

Sgt. Rivera then advised me to transport Ms. Schneeloch to police headquarters for further investigation. I had Ms. Schneeloch exit my patrol vehicle, she was handcuffed and placed in the rear of patrol vehicle 48. I explained to her, she was being detained in regards to a motor vehicle accident with injuries. She was transported to police headquarters without incident and Sgt. Rivera transported Ms. Fancher. Officer Kalachian responded to the scene and the vehicle was impounded by A&D towing.

At police headquarters, Ms. Schneeloch was placed in the holding cell and uncuffed. While uncuffing Ms. Schneeloch, I could smell a strong odor of an alcoholic beverage emanating from her breath. Her eyes were observed to be watery and bloodshot. Ms. Fancher was placed in the interview room and uncuffed by Sgt. Rivera. Teaneck Police Department was contacted for a female officer to conduct a search of both parties. Officer Cho #394 searched both female parties and all items were inventoried.

Detective Laferrera #104, the on call detective, was contacted to respond to headquarters to assist with the investigation. The registered owner, Ms. Rachael Schneeloch, was contacted to respond to police headquarters. I again attempted to gather Ms. Dallas Schneeloch's pedigree information and she provided me with a possible last name of Schneeloch but stated she was unsure what her last name was on her driver's license. A DMV check was conducted and confirmed her identity by her New Jersey driver's license photo.

Detective Laferrera arrived at police headquarters and conducted an interview with Ms. Fancher. Ms. Fancher explained, Ms. Dallas Schneeloch was driving when they were involved in the motor vehicle accident in the area of 178 Palisade Avenue. See Detective Laferrera's supplemental report for further details of the recorded statement. Ms. Fancher was released from police headquarters without further incident.

Ms. Dallas Schneeloch was then charged with providing false information to law enforcement and driving while intoxicated. Ms. Schneeloch was fingerprinted, photographed and processed without incident. She was then read the New Jersey standard statement for operators of a motor vehicle to which she stated "yes". After a 20 minute continuous observation period, Ms. Schneeloch was given the Alcotest. I conducted the test and Ms. Schneeloch provided two good quality breath samples, yielding a blood alcohol concentration of 0.14. The alcotest calculator determined both samples to be within acceptable tolerance.

Ms. Schneeloch was processed and issued a complaint summons for 2C:29-3B(4) Hindering Apprehension or Prosecution and 39:4-50 Driving While Intoxicated. Ms. Schneeloch was also issued numerous motor vehicle summonses. She was released under John's Law to Ms. Rachael Schneeloch. All required documents were uploaded to this report. No further police action was taken.
