ON THIS DATE, I OBSERVED A VEHICLE FLASHING IT'S HIGHBEAMS AT MULTIPLE ON-COMING VEHICLES, IN VIOLATION OF N.J.S. 39:3-60. UPON STOPPING THE VEHICLE, THE DRIVER, BONNIE MAMMOCCIO, WHO IS KNOWN TO BE CONFRONTATIONAL WITH POLICE, ADVISED THAT SHE KNEW THE MULTIPLE DRIVERS THAT SHE HAD FLASHED. IT SHOULD BE NOTED THAT THIS WAS DONE AFTER SHE HAD PASSED A POLICE CRUISER, WHICH LEADS ME TO BELIEVE THAT SHE WAS FLASHING HER HIGH BEAMS TO WARN OTHER DRIVERS OF A POLICE PRESENCE.

WHILE SPEAKING WITH BONNIE, SHE STARTED MUMBLING JARGAIN AND STATED SOMETHING ABOUT THE REASON FOR THE STOP. BONNIE ALSO HAD AN OBJECT DANGLING FROM HER REARVIEW MIRROR, WHICH COULD OBSTRUCT HER VIEW WHILE DRIVING. I KNOW OF BONNIE TO HAVE LIVED IN NEW JERSEY FOR MULTIPLE YEARS, SO SUMMONSES WERE ISSUED UNDER 39:3-17. SHE WAS ALSO ISSUED A SUMMONS FOR 39:3-60 AND 39:3-74.

BONNIE WAS FOUND TO HAVE AN ACTIVE CRIMINAL WARRANT FOR HER ARREST IN THE AMOUNT OF \$500.00. BONNIE WAS RELEASED ROADSIDE, BUT REFUSED TO SIGN THE RECOGNIZANCE FORM. BODY WORN CAMERA FOOTAGE AVAILABLE. NOTHING FURTHER TO REPORT AT THIS TIME.
