Purpose: This Affidavit/Certification is to more fully describe the facts of the alleged offense so that a judge or authorized judicial officer may determine probable cause.

1. Description of relevant facts and circumstances which support probable cause that (1) the offense(s) was committed and (2) the defendant is the one who committed it:
Officers responded to the Flamingo Inn, located at [REDACTED], in reference to a disturbance involving a reported domestic incident. The caller reported that her boyfriend had returned to the room and forcibly entered it.
Upon arrival, officers made contact with the female caller in Room 11. The female stated that the male had already fled the scene on foot and had taken her car keys. His whereabouts were unknown at that time. Officers immediately broadcast a description of the male in an attempt to locate him and gather further information.
The female victim provided details of the incident and advised there had been a prior dispute between her and the male earlier in the day. She stated the male returned later with a room key and unlocked both the lower and upper door locks. However, the metal security latch was engaged. The male then used physical force to break the latch from the wall, allowing him to gain entry into the room.
Once inside, the female asked the male to leave, which he ignored. When the female attempted to call 9-1-1, the male pushed her by the head onto the bed and took her phone. The female stated she attempted to scream for help, at which point the male covered her mouth to prevent her from being heard.
The female was eventually able to convince the male that they needed time apart and that he could return in approximately one hour. Once the male left the room, the female immediately contacted police.
Officers conducting a search for the male located him a short time later lying in the beach dunes, appearing to conceal himself to avoid police contact. The male was taken into custody and placed under arrest.
