[REDACTED] reported when he came out to leave, he noticed damage to his vehicle on the passenger side door. Male stated the white truck was not next to his vehicle when he discovered the damage. At this time the male requested a report for the damage to his vehicle. He was then provided a case number and advised. I then watched the video that was provided by Borgata Casino Security. Video was inconclusive, video showed a newer Toyota Tundra parked next to the vehicle. The vehicle pulled away a few minutes after the vehicle was parked. Video was from a distance, and it is unclear if the damage came from the white pickup truck. Borgata was able to provide a partial tag of NJ ***-FBS.

Photos of the damage were attached to the case. It is undetermined how and where the damage to [REDACTED] vehicle occurred.

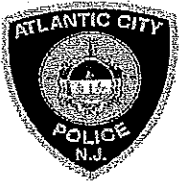
