Your first request is denied as the request is overbroad and fails to request an identifiable government record. N.J.S.A. 47:1A-1. See also, *Mag Entertainment, LLC v. Division of Alcoholic Beverage Control*, 375 N.J. Super 534, 546 (March 2005); *Michael Bent v. Stafford Township Police Dept.*, GRC case 2004-78 (2004); and, *James Donato v. Township of Union* Complaint No. 2005-182 (February 2007).

Your second request is denied as they are criminal investigatory records. N.J.S.A. 47:1A-1.1. In *Janeczko v.
