Attached you will find a redacted Arrest Report. Redactions have been made under N.J.S.A. 47:1A-1.1 – Personal Identifying Information and Privacy Interest (Social Security Number, Date of Birth, and Driver's License No.), and Criminal Investigatory Records (Mugshot).

Please be advised that the Investigation Report is being **Denied** pursuant to N.J.S.A. 47:1A-1.1 – Criminal Investigatory Records – records which are not required by law to be made, maintained or kept on file that are held by law enforcement agency which pertain to any criminal investigation or related civil enforcement proceeding. (Note: N.J.S.A 47:1A-3b lists specific criminal investigatory information which must be disclosed, which information, where applicable, is already included in the arrest report provided). This record is considered exempt.

The matter involving Nakira M. Griner regarding to the February 2019 death of her son, Daniel Griner, is currently under appeal with the New Jersey Appellate Court and remains an open court matter pending adjudication. All evidence in this case is in the possession of the Cumberland County Prosecutor's Office.

Please be advised that the interrogation footage is being **Denied** pursuant to N.J.S.A. 47:1A-1.1 Criminal Investigatory Records; Possession Cumberland County's Prosecutor's Office.

Your request is also denied under the common law because the State's interest in confidentiality and the victim's privacy interests outweigh the requestor's interest in obtaining the documents.

If you believe there is some legal authority that supports your position for access to the requested documents, please notify us and we will be happy to reconsider our response or denial of access as the case may be.

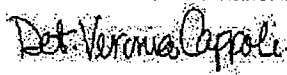
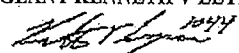
