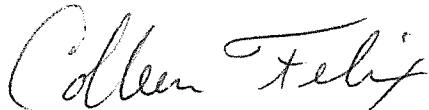

ON 5-5-2013- I RESPONDED TO 347 38TH STREET SOUTH FOR THE REPORT OF MISSING JEWELRY JUST DISCOVERED.

UPON ARRIVAL SPOKE WITH AMY KENNEDY AND SHE SAID ON 5-4-2013 WHILE GETTING READY SHE DISCOVERED MULTIPLE PIECES OF JEWELRY MISSING FROM HER JEWELRY BOX AND SMALLER BOXES THAT WERE ON HER DRESSER. KENNEDY SAID SHE THEN CONTACTED THE DEPARTMENT VIA SOCIAL MEDIA. THE EXTERIOR OF THE PROPERTY WAS CHECKED AND NO SIGNS OF FORCED ENTRY COULD BE DETECTED. KENNEDY DID SAY SHE FREQUENTLY LEAVES HER DOORS UNLOCKED WHEN SHE IS AWAY FROM THE PROPERTY. THE JEWELRY BOX WAS OBSERVED AND A LATENT PRINT COULD BE DETECTED ON THE THIRD DRAWER AT WHICH TIME THE DRAWER WAS COLLECTED AS EVIDENCE. KENNEDY DID SAY SHE TOUCHED THE JEWELRY BOX AND NUMEROUS SMUDGES COULD BE OBSERVED. KENNEDY ALSO SAID IT APPEARED THAT HER CHECK DUPLICATES APPEARED THEY WERE WERE GONE THROUGH NEXT TO THE JEWELRY BOX AS WELL WHICH SHE TOUCHED AS WELL. KENNEDY COMPLETED A PROPERTY LOSS REPORT VALUING THE JEWELRY AROUND \$36,850.00 AND COMPLETED A WRITTEN STATEMENT. KENNEDY SAID THE ONLY PERSON WHO WOULD HAVE ACCESS WOULD BE THE LANDLORD WHO SHE ONLY KNEW AS RICHARD [REDACTED] AND [REDACTED] S WHO RECENTLY REPLACED A BARBECUE GRILL AT THE PROPERTY. 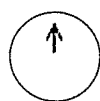

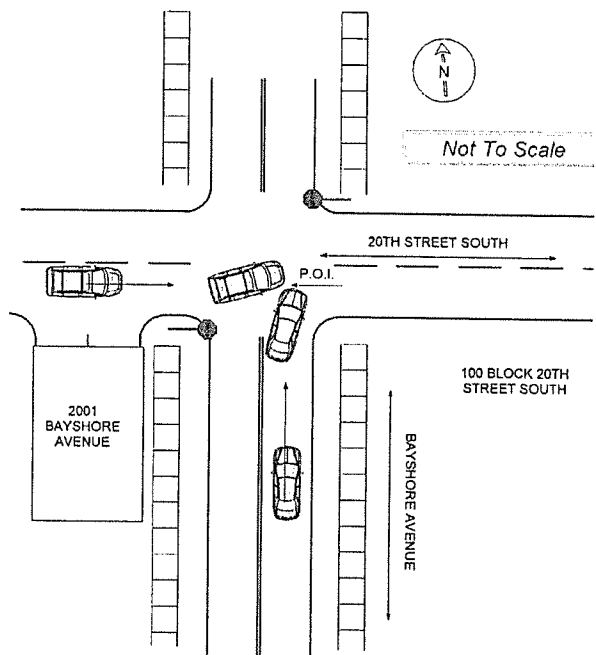
