Disposition

DISPATCHED TO THE WAWA FOR A REPORT OF AN ATTEMPTED ROBBERY. I SPOKE WITH THE VICTIM, WHO STATED THAT A TALL BLACK MALE WEARING A BLACK SWEAT SUIT HAD STOOD NEXT TO HIM WHILE HE USED THE ATM AT WAWA. AFTER COLLECTING HIS MONEY STATED HE PROCEEDED TO EXIT THE WAWA AND THE BLACK MALE FOLLOWED. STATED THE MALE KEPT SPEAKING TO HIM TELLING HIM "YOU FORGOT YOUR RECEIPT" TO WHICH REPLIED HE DID NOT GET A RECEIPT. HE THEN SAID THE MALE KEPT INSISTING HE FORGOT HIS RECEIPT AND STATED THAT AS THE MALE FOLLOWED HIM TOWARDS RITE-AID HE TOLD THE MALE TO LEAVE HIM ALONE BEFORE THEY HAD A PROBLEM. STATED THAT THE MALE THEN PULLED HIS PANTS UP APPEARING TO GET READY TO FIGHT AND AT THIS TIME RAN INTO THE RITE-AID AND CALLED POLICE. 703 LOCATED THE SUSPECT, NOW IDENTIFIED AS INSIDE THE WAWA. REITERATED THAT HE HAD ATTEMPTED TO GIVE HIS RECEIPT FROM THE ATM AND THAT AFTER ATTEMPTING TO DO SO BECAME AGITATED AND THE TWO EXCHANGED WORDS BEFORE PROCEEDED TO RITE-AID AND RETURNED TO WAWA. NO THREATS, PRESENTATION OF WEAPONS OR PHYSICAL FORCE WERE USED DURING THE ALTERCATION. WAS RAN 60 AND FOUND TO BE NEGATIVE. BOTH PARTIES WENT THEIR SEPARATE WAYS WITH NO FURTHER ISSUE.
