ON THE ABOVE DATE AT APPROXIMATELY 2129 HOURS, THIS WRITER RESPONDED TO 54 FIFTH STREET FOR A REPORT OF A SUBJECT THAT FIRED A SHOTGUN IN A RESIDENCE AND THAT THE ACCUSED WAS NO LONGER ON LOCATION. UPON ARRIVAL, I SPOKE WITH THE VICTIM [REDACTED] HE ADVISED THAT HIS STEP SON [REDACTED] AND HIS FRIEND WERE BANGING ON THE BACK DOOR. HE ADVISED THEM THAT IT WAS AFTER 9 O'CLOCK AND THAT THEY WERE NOT ALLOWED IN THE HOUSE AFTER 9. HE THEN ADVISED THAT [REDACTED] FRIEND "CHEVY" BEGAN KICKI

NG AT THE BACK DOOR AND [REDACTED] BEGAN CLIMBING ONTO THE PORCH ROOF. AT THIS TIME [REDACTED] MOTHER OPENED THE BACK DOOR AND LET THE BOYS IN. AT THIS TIME AN ARGUMENT ENSUED BETWEEN [REDACTED], CHEVY AND [REDACTED] ABOUT THEM COMING IN AFTER 9 OCLOCK. [REDACTED] ADVISED THAT CHEVY SAID WORDS TO THE EFFECT "IM TIRED OF THIS SHIT" AND LEFT THE ROOM. SHAW ADVISED THAT AFTER SEVERAL SECONDS, CHEVY RETURNED TO HIS BEDROOM DOOR AND HE WAS HOLDING A SHOTGUN. [REDACTED] ADVISED CHEVY SAID WORDS TO THE EFFECT "WHO THE FUCK YOU TALKIN TO" AND POINTED TH SHOTGUN AT HIM. [REDACTED] ADVISED THAT HE GRABBED AN OBJECT NEXT TO THE BED AND SWUNG IT AT THE GUN. [REDACTED] ADVISED THAT THE SHOTGUN DISCHARGED INTO HIS BEDROOM CEILING. AT THIS TIME CHEVY AND [REDACTED] LEFT THE RESIDENCE OUT THE FRONT DOOR. [REDACTED] ADVISED THEY GOT INTO A GRAY CHEVY MALIBU AND LEFT THE AREA. THIS WRITER OBSERVED A HOLE IN THE CEILING IN SHAW'S BEDROOM AND THERE WAS AN EXPENDED 12 GAUGE SHOTGUN SHELL ON THE BEDROOM FLOOR. THERE WAS ALSO ANOTHER SHOTGUN SHELL OBSERVED ON THE LIVINGROOM FLOOR. [REDACTED] WAS ASKED WHAT CHEVY'S NAME WAS AND HE ADVISED THAT HE DID NOT KNOW BUT THAT THEY WERE ALLOWING CHEVY TO STAY AT THEIR HOUSE DUE TO HE HAD NO PLACE TO STAY. HE DESCRIBED CHEVY AS BEING APPROXIMATELY 6'3" TALL WITH A LARGE BUILD 260 LBS, RED SHORT HAIR WITH RED FACIAL HAIR. [REDACTED] ADVISED THAT CHEVY NORMALLY DRIVES A RED PICK UP TRUCK AND THAT HE BELIEVED THAT THE GRAY MILIBU WAS HIS MOTHERS CAR. A PIECE OF MAIL WAS RECOVERED FROM THE RESIDENCE THAT IDENTIFIED CHEVY AS BEING BRYON HALSTEAD AND THE RESIDENCE DISPLAYED WAS 160 WEST AVE APT 616, WOODSTOWN NJ 08098. COUNTY DISPATCH WAS ADVISED TO CHECK DMV RECORDS FOR ANY VEHICLES REGISTERED TO BRYON HALSTEAD. COUNTY DISPATCH ADVISED ME TO CALL THEM DUE TO THEY HAD INFORMATION ON THE GRAY MALIBU DUE TO A PREVIOUS CALL THAT OCCURED IN WOODSTOWN BORO. DISPATCH ADVISED THERE WAS A PREVIOUS CALL IN WOODSTOWN INVOLVING A BRYON HALSTEAD TAKING HIS MOTHERS VEHICLE A GRAY 2005 CHEVY MALIBU BEARING NJ REGISTRATION YXP76L. COUNTY DISPATCH WAS THEN ADVISED TO PLACED A PICK UP AND HOLD ON THE VEHICLE. DET. MIKE PELURA WAS ADVISED OF THE INCIDENT AND RESPONDED TO THE SCENE. AT 2231 HOURS COUNTY DISPATCH ADVISED THAT THE VEHICLE WAS STOPPED IN SOUTH HARRISON TOWNSHIP AND THAT A 12 GAUGE SHOTGUN WAS RECOVERED FROM THE BACK SEAT OF THE VEHICLE. BRYON HALSTEAD AND [REDACTED] WERE TAKEN INTO CUSTODY AND TRANSPORTED BACK TO THE SALEM CITY POLICE DEPARTMENT BY THE NJSP WOODSTOWN BARRACKS. THE SHOTGUN WAS TURNED OVER TO THIS WRITER BY TROOPER LEGETTI. BRYON HALSTEAD WAS INTERVIEWED BY DET. PELURA AND CHARGED WITH AGGRAVATED ASSAULT, UNLAWFUL POSSESSION OF A WEAPON AND POSSESSION OF A WEAPON FOR AN UNLAWFUL PURPOSE AND POSSESSION OF A WEAPON BY A CONVICTED FELON. HE WAS PLACED IN THE COUNTY JAIL IN DEFAULT OF BAIL.
