Mr. Michael,

The Egg Harbor Township Police Department received your Open Public Records Act (OPRA) request on October 14, 2025. This response to your request is being provided to you on the 4th business day after the custodian's receipt of payment request.

Mr. Michael,

The Egg Harbor Township Police Department received your Open Public Records Act (OPRA) request on October 14, 2025. The Deputy Custodian of Records, Captain Brian Keane received your OPRA request on October 14, 2025. As such the seven (7) business day deadline for response to your request is October 23, 2025. See information below.

OPRA allows public agencies to impose special service charges whenever the nature, format, manner of collation, or volume of a government record embodied in the form of printed matter to be inspected, examined, or copied pursuant to this section is such that the record cannot be reproduced by ordinary document copying equipment in ordinary business size or *when fulfilling a request requires an extraordinary expenditure of time and effort*. Special service charges must be based upon the actual direct cost of providing the copy or copies. See N.J.S.A. 47:1A-5.c.

OPRA mandates that the requestor shall have the opportunity to review and object to the charge prior to it being incurred. See N.J.S.A. 47:1A-5.c. As such, a detailed estimate is provided below:

The BWC Recordings you are requesting requires a review, redaction and supervisory review before release of approximately 100.10 minutes of media. The cost to fulfill this request is \$127.46, which includes 4 discs, postage and an envelope. This is for case 25-50365.

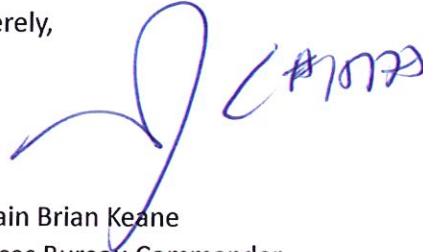
Once we received payment, we will process your request.
