## Narratives

### Original Narrative

**01/05/2025 04:44:02**

On the above date and approximate time, patrols responded to [REDACTED] for an unwanted guest. The caller, Shane Chamberlin stated he is not home at this time and his ex-girlfriend, Kierston Riley, is sending him snapchats from his bedroom. Chamberlin stated that several family members are home at this time. Upon our arrival, patrols made contact with Kierston Riley in her vehicle in front of the residence. Patrols asked Riley if she was sending snapchats from Chamberlin's bedroom, and she stated, "I was." Patrols then asked Riley how she entered the residence, and she stated, "The door was unlocked." Patrols then asked Riley if anybody else knew she was in the residence and she stated, "No." Ptl. Mejorado remained with Riley at her vehicle while I made contact with the homeowners.

I then made contact with Thomas and Justine Chamberlin and advised them of the situation. Justine stated "I woke up because I saw someone walk this way, I thought my kids came home, and then I saw his bed unmade and her jewelry was sitting there. What gives her the right to walk into my house?" I then advised that Riley stated the front door was unlocked, and Justine stated that it is always unlocked for her sons. I then asked if they have told Riley she is not allowed to be here, and Justine stated she told Shane to tell Riley that she is not welcome here, but she is unsure if Shane told Riley. Justine then stated "Whether our front door was unlocked or not, she shouldn't have come in our house".

I then went back to Ptl. Mejorado and Riley. Patrols then asked Riley how long she has been at the residence and she stated "2 hours." I then called AP Henderson and advised her of the situation. AP Henderson advised to charge Trespassing 2C:18-3A a fourth degree. Riley was then placed under arrest and was read her Miranda Rights. I then escorted Riley back to headquarters for processing.

Once patrols arrived at headquarters, I escorted Riley into the processing room. I then completed a Miranda Warning form with Riley, which she signed. I then fingerprinted Riley. I then completed Complaint Summons : 1902S2025000002 on ECDR. Ptl. Kuncken completed an arrest card and DVOR with Riley. I then issued Riley the Complaint Summons and CJP notice and advised her of her Sussex County Superior Court date of January 22, 2025 at 1:00 PM. Ptl. Kuncken then transported Riley back to her vehicle.
