**Narrative**

On 02/14/18 I responded to 3 Princeton Dr for a call about a suspicious piece of mail that was sent to the caller. Upon arrival I met with Robert Bennett who advised that he received one green envelop from global mail addressed to 3 Princeton Dr however the mail had be addressed to Joseph Mauro's (who lives at 14 Princeton Drive). Mr. Bennett then provided the mail from the United Teletech Financial Federal Credit Union (PO Box 660073, Dallas TX 75266-0073) which appeared to contain checks from a checking account. Due to an extensive history and current legal actions being taken between the two parties Mr. Bennett requested the mail be checked for possible fraud. Mr. Bennett advised that he did not want to open the mail due to the fact it was not addressed to him.

I made contact with Mr. Mauro about the incident at 14 Princeton Dr. He advised that the mail often gets mixed up in the mail boxes ever since they sub-divided the lots on the street. Mr. Mauro opened the mail and it was confirmed that the name on the checks was Joseph S Mauro and the address on the checks was 14 Princeton Dr. In addition Mr. Mauro confirmed that the account number on the checks belonged to his checking account.

I returned to 3 Princeton Dr to explain the situation to Mr. Bennett. After he was advised Mr. Bennett stated that he was going to check with the Federal Credit Union to confirm that Mr. Mauro's name was not linked to his accounts. I advised Mr. Bennett if Mr. Mauro's was linked to his account to provided documentation and to contact our department for further investigation. NFPA
