INITIAL: ON 10/28/2024 AT APPROXIMATELY 1510 HOURS, I PATOLMAN DENHAM RESPONDED TO 142 DECATUR STREET (FINS BAR AND GRILL) FOR A REPORT OF A DISPUTE.

INVESTIGATION: UPON ARRIVAL, PATROLMAN ATKINSON OF THIS DEPARTMENT WAS SPEAKING TO THE CALLER, WHO WAS IDENTIFIED AS JASON VOIT. AT THAT TIME, I WENT TO FINS BAR AND GRILL WHERE I SPOKE WITH STAFF WHO STATED THAT VOIT HAD BEEN IN FINS FOR APPROXIMATELY THREE (3) HOURS SITTING AT THE BAR. WHILE VOIT WAS AT THE BAR HE MADE UNCOMFORTABLE STATEMENTS ABOUT THE HOST [REDACTED] AND HIS SKIN COLOR WITH PATRONS AT THE BAR. WHILE LEAVING VOIT SAID TO [REDACTED] "I BET YOU WANNA DIE", WHICH TURNED INTO A DISPUTE. VOIT WAS THEN ASKED TO LEAVE MULTIPLE TIMES AND BECAME ARGUMENTATIVE WITH STAFF BUT ULTIMATELY LEAVES. [REDACTED] WAS GIVEN THE OPTION TO SIGN COMPLAINTS WITH A GUARDIAN IF HE WISHES.

A SHORT TIME LATER, VOIT CALLS FINS AND WISHES TO SPEAK TO THE MANAGER, WHILE SPEAKING WITH THE MANAGER WHO HAS A SLIGHT ACCENT, VOIT DEMANDS TO SPEAK TO SOMEONE ELSE WHO CAN SPEAK ENGLISH.

CONCLUSION: ULTIMATELY VOIT WAS TRESPASSED FROM FINS, UGLY MUG, FISH MARKET AND DELANEYS. NO FURTHER ACTION TAKEN.

78. Narrative On Monday, October 28, 2024, I, Officer Atkinson, responded to Fins Bar & Grill (142 Decatur Street Cape May, NJ 08204) for a report of a dispute. It was reported to officers the caller will be in the area of Henry's (407 Washington Street Cape May, NJ 08204) in a jeep awaiting the arrival of officers. Upon my arrival, contact was made with the caller, later identified as, Jason Voit. Voit was standing outside his vehicle which was parked on Lyle Lane. Officer Denham spoke with the other party at Fin's. Voit informed me that he was at Fin's Bar and Grill where he had lunch and drinks. While leaving the establishment, Voit stated he asked the host, "how much do you hate life right now?". Voit stated he said this due to his background in hospitality and seeing that the restaurant was "dead". Voit then stated the host informed him he was a minor and was then accused of "hitting on a minor". Voit informed me that he was threatened and accosted as he was leaving the establishment. Voit was then provided the opportunity to sign complaints which he declined to do so. Voit was then informed that he was trespassed from Fin's, Ugly Mug, Fish Market, and Delaney's. No cause for further action at this time. Voit was able to provide a copy of the recording which captured the incident at Fin's. The recording was uploaded to evidence.com
