On January 4th, 2024 at approximately 2055 hours, P.O. Donato and myself were dispatched to [REDACTED] Kennedy Lane on a report of a unknown vehicle parked in the resident's driveway. NJ registration D57SMD, 2020 KIA Optima, color white. I performed a DMV inquiry using Infocop and the vehicle was coming back stolen out of Garfield, NJ, NIC #V955754836.

Upon arrival, we activated our BWCs and observed the vehicle. The back passenger side window was smashed in. The vehicle was unoccupied. P.O. Donato remained with the vehicle and I canvassed the area, with negative results. I spoke with the residents, Navyagopa Garapati and Vasanthal Raparathi, at [REDACTED] Kennedy Lane and they stated that the vehicle had been parked in their driveway since approximately 2:30 PM. They thought it was just a neighbor's car. Captain Biamonte arrived on scene at this time.

Police headquarters contacted Garfield Police Department to confirm the stolen vehicle. Garfield Police Department requested for us to contact our on call tow and take possession of the vehicle. Nick's Towing was notified. I observed a doorbell camera at [REDACTED] Veterans Drive and made contact with the resident, later identified as Mr. Lee Min. Mr. Lee provided me with camera footage showing that the vehicle was parked in the driveway at [REDACTED] Kennedy Lane since approximately 7:04 AM on 01/04/2024. The video did not show anyone exiting the vehicle. Nick's Towing arrived on scene and took possession of the vehicle (see tow report). No further action taken.

On 09/23/24 at approximately 0727 hrs. I was detailed to 362 Union Avenue on the report of a stolen motor vehicle. Upon my arrival, I was met by Sadaf Raza at the front door. She is reporting that someone apparently entered her residence and removed her pocket book from the kitchen counter. The pocket book is a brown Louis Vuitton bag valued at approximately \$3,000 and it contained her N.J. Driver's License along with several credit cards, approximately \$20 in cash, house keys and car keys to the above listed vehicle which she is also reporting as stolen. I was informed that the RING camera shows the vehicle there in the driveway at approximately 0430 hrs. and it was gone at approximately 0530 hrs. The RING camera did not activate during the theft of the vehicle. Det./Capt. Biamonte arrived on scene. Upon further investigation it appears that the unknown actor(s) forced open the rear sliding door on the South (rear) side of the house.

On Tuesday, 01/30/2024, at approximately 2239 hours, Sgt. Manfredonia and I were dispatched to 100 Rosie Square for a report of a possible theft of a motor vehicle.

Upon arrival, officers activated their body worn cameras. We were met in the front of the complex by Mr. Paul Shuler and his wife, Mrs. Tywana Greene-Shuler. Mrs. Shuler informed us that her husband's vehicle was missing. Mr. Shuler provided us with the vehicle's description and registration. The vehicle is a 2020, Chevrolet Blazer, color red, displaying New York registration KDH3502. Headquarters was notified and contacted Nutchies Towing to see if they had recently towed that vehicle from the property. Nutchies Towing advised headquarters that they did not tow that vehicle. Mrs. Shuler stated that she had contacted her bank and the bank confirmed that the vehicle was not repossessed. Mrs. Shuler added that the vehicle only has one key fob which she currently had in her possession. The vehicle was confirmed stolen and headquarters was advised.

Mrs. Shuler stated that the last time she saw the vehicle was around 1800 hours when she had arrived home. Mrs. Shuler stated that she parked the vehicle in the main parking lot located in front of the 100 Rosie Square building. Mrs. Shuler advised me that inside the vehicle there are two MTA badges for her and her husband (ID # [REDACTED] # [REDACTED]), a Greco 3-in-1 car seat, a Municipal Credit Card, and various clothing items. Mrs. Shuler stated that the approximate monetary value of the items inside the vehicle is \$3,000. In addition, the approximate monetary value of the vehicle is \$30,000.

Mrs. Shuler was advised to contact and notify MTA of the incident and inform them about her and her husband's ID badges. Mrs. Shuler was advised to also contact and notify her bank and cancel the credit card that was left inside the vehicle.

The area was canvassed as well as the garage and there were no signs of the vehicle. While canvassing the area, I observed multiple video security cameras located on the front of the 100 Rosie Square building that may have captured the incident. The detective bureau will need to follow up with the management company in order to obtain the video footage.

Back at police headquarters, the vehicle was entered into NCIC as stolen. NCIC #V075809470 was generated. Sgt. Manfredonia contacted and informed Det./Sgt Mueller of the incident.
