Body Worn Camera Used NARRATIVE On 06/30/2022 at approximately 21:05 hours, I responded to 110 Marl Road for the report of an explosion. Upon arrival, I observed a crowd of people in the roadway when I was approached by a female who stated that Joseph Vitale called the police in reference to the loud explosion. Mr. Vitale stated he was outside having dinner at his residence when he heard a loud explosion at 2052 hours (30 seconds) in the area of 110 Marl Road. Mr. Vitale stated that typically when he has people over and vehicles are parked in front of his residence, they blast off explosions in the area, but is uncertain of the exact location. He stated that this time he heard a females voice state "oh my god my leg, call the police". Mr. Vitale stated

that he came to the area where he heard the cry for help with his neighbor Dan Brown to locate the possible injured female. While speaking with Mr. Vitale, the female on scene who was later identified as Brooke Budd stated that she was injured and asked Mr. Vitale if he was going to help her. I asked the female if she needed medical attention and she stated yes that she was emotionally injured and that she has been harassed for two years. At that time, I requested dispatch to have EMS respond to my location for a emotionally injured female. I advised Mrs. Budd to speak with the other officers on scene while I spoke with Mr. Vitale and Mr. Brown. Once Gloucester County EMS arrived on scene, Mrs. Budd denied any further medical treatment.

I spoke with Dan Brown in regards to the incident and he stated that he was having dinner at Mr. Vitale's residence when he heard a loud explosion. He stated that he pulled up his nature camera which is located down by the creek and heard a female's voice stating oh my god my leg, please call the cops. Mr. Vitale was able to play the video for me where you can clearly hear a female's voice scream oh my god my leg, call the fucking cops. Mr. Brown stated that when they turned onto Marl Road, he observed a group of people standing in the driveway of 110 Marl Road and they immediately began screaming at them in the middle of the street. Mr. Brown stated that Mrs. Budd grabbed his scooter by the handles and would not let him pass by. He advised that he kept his hands on the handle bar the entire time and did not touch Mrs. Budd at any time. Both Mr. Vitale and Mr. Brown advised that they would just like to have the incident documented at this time and would respond to police headquarters at a later date. I subsequently checked the area for the source of the explosion and was met with negative results.

Mr. Vitale provided me with video footage via email(See attached) along with additional information that was not provided on scene via email (See attached).

No further action by this officer at this time.

NARRATIVE			
On Monday, August 08, 2022, at approximately 0930 hours, Joseph Vitale and Daniel Brown came to police headquarters to report an incident of harassment. This incident stemmed from the events that occurred on June 30, 2022. Brown and Vitale advised that on 08/05/2022 at approximately 1900 hours, they were riding their electric scooters on Marl Road to go check out their nature camera that is posted by the creek. A resident of Marl Road, Frank Durso, began harrassing them and stated that he was thankful for them feeding the bucks so he could shoot them and that "they were the best." Vitale provided video of the incident. (See Attached Video). Vitale and Brown both fear for their lives and stated that they do not feel safe around Durso. Later on that night, at approximately 2230 hours, Brown and Vitale went down Marl Road again on their electric scooters with Brown's children, but this time to check out a music festival that was occurring at the end of the street. Frank Durso, Dana Durso, and other friends of the Durso's began yelling profanities towards Brown and Vitale with the children present. Vitale believed they had been drinking and stated that Dana had a drink in her hand. Vitale also provided footage of this incident. (See Attached Video). Again, Vitale and Brown were fearful for their lives and the lives of Brown's children. While at the station, Brown and Vitale explained the situation that occurred to them on 06/30/2022. I had them write out statements in reference to that incident. (See Attached Written Statements). Based on the evidence and statements provided, Brooke Budd was charged with 2C:33-4B in reference to the incident on 06/30/2022, that involved her grabbing Daniel Brown's electric scooter and not allowing him to ride on Marl Road. (See Ptl. B. Collin's Initial Report for Further). Brown and Vitale left the station without further incident.
