DAVID YOUSSEF, having been charged upon oath, before a Judge in the said County of Monmouth, with Aggravated Assault, Two (2) Counts of Terroristic Threats, Endangering the Welfare of Others, Resisting Arrest and Aggravated Assault on a Police Officer, and having in writing, addressed to the Monmouth County Prosecutor, waived prosecution by indictment upon said charge(s), and said waiver having been duly reported and granted by the Court:

FIRST COUNT

AGGRAVATED ASSAULT – THROWING BODILY FLUID

FOURTH DEGREE CRIME

The County Prosecutor of said County of Monmouth, alleges that the said, DAVID YOUSSEF, on or about May 18, 2020, in or about the Township of Aberdeen, County of Monmouth, and within the jurisdiction of this Court, did commit the crime of Aggravated Assault by throwing bodily fluid, at B.M., a law enforcement officers, or otherwise purposely

subjecting B.M. to contact with a bodily fluid, while in the performance of his duties, contrary to the provisions of N.J.S.A. 2C:12-13, and against the peace of this State, the Government, and dignity of the same.

SECOND COUNT

TERRORISTIC THREATS

SECOND DEGREE CRIME

The County Prosecutor of said County of Monmouth, alleges that the said, DAVID YOUSSEF, on or about May 18, 2020, in or about the Township of Aberdeen, County of Monmouth, and within the jurisdiction of this Court, did commit the crime of Terroristic Threats, by threatening to commit a crime of violence with the purpose to terrorize E.Y. and/or S.Y., or in reckless disregard or the risk of causing such terror, contrary to the provisions of N.J.S.A. 2C:12-3a, and against the peace of this State, the Government, and dignity of the same.

THIRD COUNT

TERRORISTIC THREATS

SECOND DEGREE CRIME

The County Prosecutor of said County of Monmouth, alleges that the said, DAVID YOUSSEF, on or about May 18, 2020, in or about the Township of Aberdeen, County of Monmouth, and within the jurisdiction of this Court, did commit the crime of Terroristic Threats, by threatening to commit a crime of violence with the purpose to terrorize Law Enforcement Officers, or in reckless disregard or the risk of causing such terror, contrary to the provisions of N.J.S.A. 2C:12-3a, and against the peace of this State, the Government, and dignity of the same.

FOURTH COUNT
ENDANGERING THE WELFARE OF OTHERS

FOURTH DEGREE CRIME

The County Prosecutor of said County of Monmouth, alleges that the said, DAVID YOUSSEF, on or about May 18, 2020, in or about the Township of Aberdeen, County of Monmouth, and within the jurisdiction of this Court, did commit the crime of endangering the welfare of others, did recklessly engage in conduct which created a substantial risk of causing bodily injury or illness to another by spitting at or near B.M. while stating he was positive for COVID-19 during a pandemic, contrary to the provisions of N.J.S.A. 2C:24-7.1(a)(2), and against the peace of this State, the Government, and dignity of the same.

FIFTH COUNT
RESISTING ARREST
THIRD DEGREE CRIME

The County Prosecutor of said County of Monmouth, alleges that the said, DAVID YOUSSEF, on or about May 18, 2020, in or about the Township of Aberdeen, County of Monmouth, and within the jurisdiction of this Court, did commit the crime of Resisting Arrest, by purposely preventing or attempting to prevent B.M., a law enforcement officer, from effecting an arrest, by using or threatening to use physical force or violence against the law enforcement officer or another or by using any other means to create a substantial risk of causing physical injury to the public servant or another, contrary to the provisions of N.J.S.A. 2C:29-2a(3), and against the peace of this State, the Government, and dignity of the same.

SIXTH COUNT

AGGRAVATED ASSAULT ON POLICE OFFICER

FOURTH DEGREE CRIME

The County Prosecutor of said County of Monmouth, alleges that the said, DAVID YOUSSEF, on or about May 18, 2020, in or about the Township of Aberdeen, County of Monmouth, and within the jurisdiction of this Court, did commit the crime of aggravated assault by using or threatening to use physical force or violence against the law enforcement officer or another, or recklessly causing bodily injury to B.M., a law enforcement officer acting in the performance of his duties while in uniform or exhibiting evidence of his authority, or by using any other means to create a substantial risk of causing physical injury to the public servant or another, contrary to the provisions of N.J.S.A. 2C:12-1b(5)(a), and against the peace of this State, the Government, and dignity of the same.
