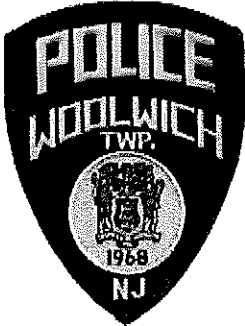

NARRATIVE On Sunday October 3, 2021 at 2231 hours District 23 units were dispatched to 110 Marl Road in reference to a fireworks complaint. Upon arrival in the area, I was met by the caller, Frank R Durso. Frank stated that he's been having ongoing issues with several neighbors in the immediate area and believes that tonight, they set fireworks off on the second entrance to his property that disturbed him in his residence. While driving down Marl Road, it was determined that the box of fireworks that were lit off, were actually in the driveway of 116 Marl Rd, a neighbor's property. All labels on the box of fireworks were removed. Frank believed that he was the intended target of the fireworks, which were meant to annoy him and cause him panic/alarm. Frank further stated that he had dead skinned animals thrown in his front lawn as well as nails in his driveway recently, that he believes are all related to the ongoing issues he's been having with his neighbors. Frank was advised to get surveillance on his property to help catch the suspect(s) who have been harassing him. In the meantime, I would document this incident for him.

NARRATIVE

Thursday, October 7th, 2021

A written request was formed and emailed to Sky King Fireworks manager, Jay Hays, regarding recent purchase history of the specific firework located and seen photographed attached. A potential suspect name, Matthew Warner, was supplied due to the victims, Frank Durso's, statements.

It shall be noted, during this time Brian Budd communicated, via email, with myself on numerous occasions noting recent but separate incidents of harassment by Matthew Warner. These incidents include, Mr. Warner allegedly leaving the roadway with his vehicle and purposefully running over yard signs advertising Mr. Budd's company. (Emails attached.)

In regards to drone activity, Special Agent David Bonk- FAA, has been notified and briefed of the incidents. This office will follow his recommendations when received.

Wednesday, October 20th, 2021

I received a response from Sky King Fireworks in reference to my prior request. (Both the initial request and response are seen attached.) On the response, it shows a purchase from Matthew Warner, of 34 Ashford Court, made at the Easton, PA store on 09/05/2021. The Easton, PA store in particular is approximately 102 miles away from this location and/or a 2 hour 50 minute drive. (Note: no camera footage available due to a 30 day storage window.) The Sky King Fireworks manager, Jay Hays, stated they do not break down the purchases by specific item, only by price, and at the time of purchase there were approximately 10 other items matching the "500 Grams Twisted 18 Shots" price point. (The specific item in question is currently on sale for "buy one, get one for \$99.00 sale".)

Thursday, October 21st, 2021

An email statement request was sent to Matthew Warner utilizing a prior email used to communicate with him. (matt@matttek.com)

Requests to speak with me further, were denied by Mr. Warner. The email exchange can be seen attached.

At this time, there is no direct evidence linking anyone specifically to the fireworks incident.

With all current information at hand, criminal charges will not be pursued at this time by this office.

Nothing further at this time.

Detective Beckett,

I would like to know if Matt Warner & Joe Vitale are going to be charged with Criminal Trespassing pursuant to 2C:18-3. They need to be held accountable for their actions, so they don't do this again in the future to my family or others. These two individual trespassed on Mr. Durso and I's property. Their intent was to invade our privacy pursuant to 2C:14-9(a) as I explained in a previous conversation. Myself and my son as well as Mr. Durso and his son frequently use the restroom outside next to a tree or bush as the house is too far away from where the kids ride. This is done because we reasonably believe that we will not be observed by anyone because it is private property without any public right of view. I understand that what I am saying may not fit the usual mold of these laws because it introduces new technology that was not considered at the time of enactment but, I also understand that the law isn't just black and white, that law enforcement, prosecutors and judges have the great power of discretion. This discretion is what is used to make determinations on grey areas of the law. These two individuals trespass onto a property that they have no right to be there and filmed in an area where we have a reasonable expectation of privacy. They have been doing this for over a year. While the FAA has jurisdiction over the navigable airspace, they have no jurisdiction over what would be considered public or private land and only advise flyers that they would require permission to fly on private property. This is where law enforcement steps in to determine if there is trespassing or not. Just ask yourself why these two individuals have been eluding us and law enforcement for over a year now. They are not outside in plain view with their remote nor are they landing these drones at their house. They have been landing somewhere else and retrieving it at a later time in their vehicles to conceal their identity. We have been saying it has been them for over a year now. This behavior would indicate that they knew what they were doing was unlawful. Just so that you understand these are a far cry from toy drones that one might see on amazon for \$150. I emailed you previously that my research led me to believe this was a Mavic series drone. After receiving the police report and its video's, Mr. Warner's videos are labeled with the DJI logo which as suspected is the manufacture of the Mavic series drone. Now that this is established let me tell you about the capabilities of these drones.

As you can see this is no toy. In the hands of a reckless user that does not follow safety guidelines this is a very dangerous weapon. Please advise on how the dept plans to proceed.

Dear Mayor, Deputy Mayor and, Committee,

My name is Brian Budd and I live at 1408 state highway 45. My neighbors and I have expressed dire concern at previous township meetings for individuals within the township that have been weaponizing drones for the intent to harass, stalk, spy, invade privacy where there is a reasonable expectation of privacy and interfere with the use and enjoyment of our properties here in south Harrison township. It is my understanding that the township has tried to investigate and consider a drone ordinance here within the township but was unsuccessful in finding a place where the municipality would have the authority to intervene with the FAA to control such drone activity. I have uncovered some information that may be of use in understanding the issue at hand more in depth. I have attached a Letter by the Federal Aviation Administration from Dec 17th of 2015. It states that the FAA only has control over drones/aircraft in flight, such as flight altitude, flight paths, operational bans, and regulation of navigable airspace. Furthermore, it states that the FAA has no jurisdiction over state and local laws within the state and local police powers such as land use, Zoning, Privacy, trespass, and law enforcement operation. The letter provides contact info to the chief council in Washington D.C. to provide guidance to State and local municipalities in creating laws pertaining to drone usage. I also have attached the current laws New Jersey has in place, which Establishes that operating a UAS in a manner that endangers the life or property of another is a disorderly person offense. Gloucester county parks and recreation have recognized the potential for abuse and the threat of bodily injury and as such have made it illegal to fly a drone in any park or recreation area in the county of Gloucester. The state has also recognized the issue pertaining to privacy and trespassing and has entered senate bill 3318. If this bill passes it will

supplement the current trespassing and privacy laws to include drone usage. I have also attached Monroe Township of Gloucester county's very in-depth drone ordinance making it illegal to fly a drone over private property without written permission. I have also included a video from the pilot institute that explains the FAA drone regulations in layman's terms. The FAA has 4 Categories of drones based on weight and kinetic energy upon impact that could severely damage property or injure people. As of now there are no consumer drones that have been approved by the FAA in any category as the manufactures have not been able to develop drones meeting their criteria and thus have not been given the FAA's certificate of approval. What does this mean. It means that there are no drones currently able to have sustained flight over people or moving vehicles. The FAA defines a moving vehicle as anything that propels a human. The FAA defines sustained flight as hovering in a general area for a period of time. In addition to this, as part of the FAA's safety standards all drones must be equipped with prop guards to protect people upon the ground from severe laceration occurring from the propeller blades that can spin at 9000 RPM. My neighbors and I have countless videos of a drone sustaining flight on private in an area where there is an expectation of privacy over my family, myself and my neighbors with no prop guards posing the threat of bodily injury to my family, friends and neighbors and our property. I would ask that you look over this information and see if we can come together to provide a means of enforcement and accountability to the reckless behavior exhibited by some individuals that are abusing the use and purpose of drones within the township. Please let me know if I can be of any assistance in helping in any way possible.

Good morning, Detective Beckett,

I am emailing you for the purpose of documenting these ongoing issues. I understand that you will not be able to do anything about it as of now, but this information may be useful later in the future in establishing a case as Mr. Warner's unlawful behavior continues to evolve.

Last night Mr. Matt Warner drove by my house at approximately 8:30pm. My wife was out front letting our dog out. Mr. Warner was headed to the intersection of Ashford court and rt 45. Mr. Warner stopped at that intersection for a prolonged period even though there were no cars coming in either direction down rt 45. Mr. Warner then proceeded to spin his car around in the intersection screeching his tires in a reckless manner and floored the gas pedal back down Rt 45 passing my house located at 1408 state highway Rt 45 toward marl rd. He then put his left blinker on and proceeded down marl rd. where he drove across the wrong side of the road onto Mr. Durso's property and ran over my company's yard sign that Mr. Durso has on his front yard to support my business. Mr. Durso is my neighbor, but he is also a customer as well. We provided soft washing services to his log cabin and barn on June 10th, 2021. Mr. Warner runs over my sign located at Mr. Durso's front yard 1-2 times a week. I have been putting yard signs up for years to promote my business. I have put signs all over in Gloucester County, Camden County, and many other areas in the tri state. I have never had signs run over. Any signs that I put up in Woolwich are run over in the same manner that Mr. Durso's sign is. I have stopped and fixed these signs by bending the stakes back into place only to find them run over again only a few days later. In addition to this Mr. Warner has gone over to my customers house Tony Venuti's a 78-year-old man at 2 Ashford Court. After my crew completed a service on June 18th, 2021, at Mr. Venuti's home Mr. Venuti asked if we could put out a sign in his front yard to help promote my business and we did. Later that evening Mr. Warner pounded on Mr. Venuti's door and threatened him and his wife, causing his wife to cry all because they had one of my signs in their front yard. Mr. Venuti called me in a panic as he was extremely startled and upset by Mr. Warner's conduct. Mr. Warner is clearly stalking me pursuant to 2C:12-10, please correct me if I am wrong in my interpretation of this. I am meeting with Mr. Hanratty later today to provide a video of Mr. Warner's actions at the intersection of 45 and Ashford court. In addition, I have attached photos of my yard sign run over in Mr. Durso's yard. While I understand this is not conclusive evidence, I can go out on a limb here and say I'm pretty sure Woolwich police dept is not receiving other calls throughout the Township of people running over other yard signs in people's front yards nor of people being threatened in any way because they have a contractors sign up in their front yard. This is a very targeted assault towards me, and my business designed to hurt me in any way possible through emotional distress, lost revenues from marketing materials being damaged and rendered ineffective, as well as the potential loss of customers due to intimidation to these customers by Mr. Warner. My family and I have been under attack for the last year and a half by Mr. Warner and his associates, the Browns and Mr. Vitale.

Thank you for your consideration in the matter and if you need any additional information, please let me know.

Good afternoon, Detective Beckett,

I have a video provided by Mr. Hanratty. The video appears to be too large to email. I have it on a thumb drive which I can drop off as well as the explosive device for evidence. We suspect that the car leaving at approximately 10:18pm is Mr. Warner's car leaving Ashford court. It seems to be very suspicious that the car has its lights on while going through the development and then turns them off when cresting the hill and drives to the intersection of 45, then makes a left and turn onto rt 45 and turns its lights back on after what appears to be several hundred feet. While the video is not definitive, it is certainly cause for suspicion. Mr. Vitale, I believe has cameras and a tag reader that would verify who this is, but I have a funny feeling he will not provide this information. It is also interesting to note that Mr. Vitale and the Winery call about every little noise but not a single call for 18 load consecutive blasts at 10:25pm at night.

I have also provided pictures of the original explosive as well as the one we believe it to be. This could be confirmed with the manufacturer. It was purchased from sky king as it is their brand. I called sky king and was informed that a person must scan their driver's license prior to making a purchase as this is federal regulation. I was informed that they have all names and purchased on file and that they work with law enforcement regularly on these types of situations. I was informed that they can only provide the information to law enforcement. There are only two sky king locations in PA. I was told that each location only has purchase information for that location. There is no warrant needed, just sensitive information they cannot disclose to the public. If Mr. Vitale, the browns, or Mr. Warner purchased that device then at least it proves possession.

If you need anything else, please let me know. We all just want this to end and to be just left alone to live our lives. We have been dealing with this for a year and a half. We have not done anything to these people, yet they continually attack us for no apparent reason. I purchased my son an electric dirt bike so that there is no noise for them to complain about. Mr. Durso's son rides his gas dirt bike maybe once a week at best, it just doesn't make logical sense. We feel at this point there is another more serious motive behind these attacks. We all live in fear of what they will do next, they have used intimidation, harassment, stalking, mental anguish, criminal trespassing, cyber bullying, property damage, attempted assault, utilizing police resources with the intent to harass, weaponization of drones and I fear eventual bodily injury to my family, myself, or my neighbors. They are already actively doing these things and we fear that they will only continue to escalate if not stopped. I understand there is only so much the police dept can do as they continue to elude everyone so all I can do at this point is provide insight and information.

Chris,

I and my neighbors continue to hear fireworks, dirt bikes, motorcycles, engines revving, honking, and gunshots consistently day and night coming from the other side of Rt 45 for the last two to three years. In the last week alone, I have twice been ran off the road with motor vehicles. Once by the party involved in the shooting incident that lied to the police and owns the firearm used in the crime against myself and my family, he followed me with my child in the car and almost rammed into my car at a stop sign and never stopped while I was turning. And another time earlier this week by a group of dirt bikes and four wheelers that my dashcam picked up. **(Could this all be in possible retaliation for coming forward with drone footage over the gunshots?)**

As far as I am aware, Tony's sign is still there. (Never asked him to remove it, I just communicated to his wife in a very calm demeanor that I felt the sign was disrespectful to his neighbors across the street due to all the legal issues and walked away from the front door). That's my statement on that incident. I am guessing you have seen the footage from when I left the front door but just in case I am attaching my dash cam footage from my vehicle. I have had no other contact with him nor his wife since he threatened to put a bullet in my head. I do not go anywhere without a dashcam anymore due to the unsubstantiated claims that I have heard made by these untruthful individuals. To be perfectly honest with you I do not feel safe in South Harrison knowing that these three guys have guns (Frank, Brian, and Tony), have either shot and/or threatened to shoot me, at my house, and my property. Yet, no one from law enforcement has charged the dishonest owner who initially lied about the firearm used in the crime against me, or has taken away any of the firearms that have been used against my family and I in any of these crimes. I have recorded and others have recorded conversations with these individuals that confirm they are retaliating and have stated many times that they will continue to get everyone involved if they complain.

Why would I want to be retaliated against for the second time in my township by the police and members of the township? See Warner vs Township of South Harrison. And yes they settled and admitted fault. This is why I was hesitant the first time coming forward with the video. My kid can't even enjoy his Christmas present (the Toy Drone) from his grandmother anymore.

Other than the above statements, I have nothing else to add to this conversation nor want to be a part of any other conversations going forward. This township does a horrible job of protecting its law abiding citizens. My next step will be to the Attorney General of New Jersey and to the FBI for various racially slandering remarks also made by these individuals and township entities.
