This response to your request is being provided to you on the **7th** business day after the custodian's receipt of your requests.

You requested "...*Case information sheets for complaint #2022 000197...*" Because the ETPD does not have case information sheets, we requested clarification to the email above on May 17, 2022 and May 23, 2022. **We have not received clarification from you. We are interpreting your request for the following records.** They are being provided to you via email per your request:

At your option, you may either institute a proceeding in the Superior Court of New Jersey or file a complaint with the Government Records Council (GRC) by completing the Denial of Access Complaint Form. You may contact the GRC by toll-free telephone at 866-850-0511, by mail at P.O. Box 819, Trenton, NJ, 08625, by e-mail at grc@dca.state.nj.us, or at their web site at www.state.nj.us/grc. The GRC can also answer other questions about the law. All questions regarding complaints filed in Superior Court should be directed to the Court Clerk in your County.

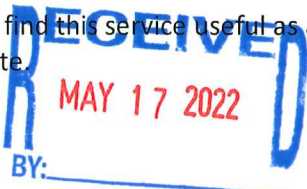

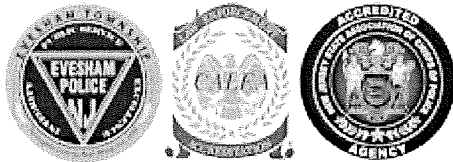

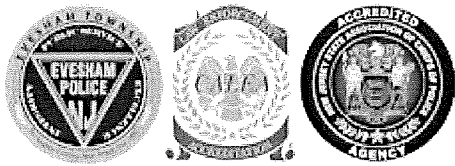
