Purpose: This Affidavit/Certification is to more fully describe the facts of the alleged offense so that a judge or authorized judicial officer may determine probable cause.

1. Description of relevant facts and circumstances which support probable cause that (1) the offense(s) was committed and (2) the defendant is the one who committed it:

On November 4, 2024, around 12pm, the Point Pleasant Police Department was notified by the Brick Township Police Department of a stabbing which took place over a road rage incident. The original incident started on Jordan Road in their jurisdiction. The Brick Township Police Department received notification from the Ocean University Medical Center that the victim was currently in their Emergency Room receiving treatment. The only information provided by the Brick Township Police Department is the suspect is in his thirties driving a small white hatchback vehicle and the victim was stabbed in the bicep which may require surgery. The incident occurred at the TD Bank located at 3301 Bridge Avenue in Point Pleasant, N.J. During the investigation the victim, Michael Frank, stated he was traveling west on Princeton Avenue and at the intersection of Jordan Road a white in color vehicle with an unknown male driver with a goatee cut in front him off and turned in front of him onto Jordan Road. The victim continued traveling west on Jordan Road while the suspect vehicle traveled in front of him. Mr. Frank said he kept a safe distance and both vehicles turned right onto Route 88 to travel east. While traveling Route 88 Mr. Frank pulled up alongside the suspect and words were exchanged between the two. Mr. Frank made a left turn onto Bridge Avenue and the suspect followed him and nearly hit his vehicle while turning. Next Mr. Frank stopped for the red light at Bride Avenue and Riverwood Avenue. The suspect entered the parking lot of the TD Bank, parked his vehicle, got out of the driver's side and began banging on the back window of his car. Mr. Frank exited his vehicle to confront the suspect, and he punched the suspect in his face with his right hand. The suspect ran back to his car, Mr. Frank followed him and punched the suspect's vehicle. Mr. Frank went back to his vehicle and felt a warm liquid in the area of his bicep and realized he was bleeding. Mr. Frank drove himself to Ocean University Medical Center in Brick for treatment where he received several internal and external stitches.

Through the investigation an area license plate reader captured the suspect vehicle, a white Toyota Rav 4 (NJ) [REDACTED]. Surveillance was obtained from TD Bank and Nicholas Ippolito was developed as the suspect. Mr. Ippolito was taken into custody on November 6, 2024. Mr. Ippolito was mirandized and stated he wished to speak to an attorney.
