Purpose: This Affidavit/Certification is to more fully describe the facts of the alleged offense so that a judge or authorized judicial officer may determine probable cause.

1. Description of relevant facts and circumstances which support probable cause that (1) the offense(s) was committed and (2) the defendant is the one who committed it:

I, Detective Verdadeiro am a Detective with the Long Branch Police Department ("LBPD"). I have participated in this investigation and am aware of the facts contained herein, based on my own investigation, as well as information provided to me by other law enforcement officers. Because this Attachment is submitted for the limited purpose of establishing probable cause, I have not included herein the details of every aspect of the investigation. Statements attributable to individuals contained in this attachment are related in substance and in part, except where indicated in quotations or otherwise.

1. At approximately 11:43 on the evening of December 31, 2017, two 911 calls were received concerning a shooting at a residence on Wall Street in Long Branch.

2. Members of the Long Branch Police Department and the Monmouth County Sherriff's Office were among the first agencies to arrive in response to the calls.

3. Entry was made into the residence and the Defendant, Scott Kologi, was arrested.

4. The four victims were identified as: L.K. (44 y.o.) the Defendant's mother; S.K., Sr. (42 y.o.) the Defendant's father; B.K. (19 y.o.) the Defendant's sister; and M.S. (70 y.o.) the long term girlfriend of the Defendant's grandfather. Subsequent autopsies confirmed that all four died as the result of gunshot injuries.

5. As part of the investigation, a rifle was secured and later identified as the weapon used in the homicides. It was identified as Century Arms Model C39V2 rifle. Subsequent investigation determined that the rifle had been lawfully purchased by a member of the Defendant's family in October of 2016. At the time of these crimes, neither the rifle nor the ammunition was locked.

6. The Defendant was advised of his rights and elected to give a formal statement to myself and Detective Andrea Tozzi of the Monmouth County Prosecutors Office. During the course of that statement the Defendant, in substance and in part, admitted killing his mother, father, sister and "grandmother." He described the steps he took in preparation for these crimes including retrieving and loading the rifle. He did not specify a motive for his actions.

7. Statements taken from the surviving witnesses corroborate the Defendant's
