The Grand Jurors of the State of New Jersey, for the County of Monmouth, upon their oaths present that SCOTT KOLOGI, on or about December 31, 2017, in or about the City of Long Branch, County of Monmouth, and within the jurisdiction of this Court, did commit the crime of Murder, by purposely or knowingly causing the death of L.K., or by purposely or knowingly causing serious bodily injury resulting in the death of L.K., contrary to the provisions of N.J.S.A. 2C:11-3a(1) and/or (2), and against the peace of this State, the Government, and dignity of the same.

SENTENCING ENHANCER

The Grand Jurors of the State of New Jersey, for the County of Monmouth, upon their oaths also present that **SCOTT KOLOGI** used or possessed a firearm while in the course of committing or attempting to commit the foregoing crime, or in the immediate flight therefrom, contrary to the provisions of N.J.S.A. 2C:43-6c.

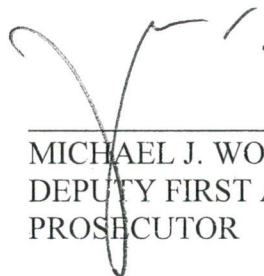

POSSESSION OF A WEAPON FOR AN UNLAWFUL PURPOSE

SECOND DEGREE CRIME

The Grand Jurors of the State of New Jersey, for the County of Monmouth, upon their oaths present that SCOTT KOLOGI, on or about December 31, 2017, in or about the City of Long Branch, County of Monmouth, and within the jurisdiction of this Court, did commit the crime of Possession of a Weapon for an Unlawful Purpose, by possessing a weapon, to wit: a firearm, with a purpose to use it unlawfully against the person L.K. and/or S.K. and/or B.K. and/or M.S., contrary to the provisions of N.J.S.A. 2C:39-4(a), and against the peace of this State, the Government, and dignity of the same.
