Purpose: This Affidavit/Certification is to more fully describe the facts of the alleged offense so that a judge or authorized judicial officer may determine probable cause.

1. Description of relevant facts and circumstances which support probable cause that (1) the offense(s) was committed and (2) the defendant is the one who committed it:

On the above date and time, I responded to the defendant's address to investigate a noise complaint. The caller had advised that four men were shooting on their property. Upon arrival I observed the four men reported, unarmed. When I asked them what they were doing the homeowner advised that they were utilizing his property as a firing range. He then proceeded to show us the range, pointing at a wooden frame structure (Barn) on the property. The target was hanging on the side of the barn, and directly behind the barn was Toms River Road (County Road 571), a busy county road. Inspection of the barn revealed that five rounds passed through the barn, and out across 571, with one strike being observed in a mailbox at 3 Kindling way (across the street) during a neighborhood canvas. While speaking with the homeowner of 3 Kindling (victim) we were advised that the homeowners Husband, Stepson, and Daughter were hanging Christmas lights in the area of the mailbox and playing in the yard all morning.

All weapons were seized pending investigation. It was during this seizure it was discovered that the semi-automatic rifle appeared to be illegally modified. Additionally, a thirty-round high-capacity magazine was located on the ground. The homeowner and defendant claimed ownership of the rifle, but not the magazine. In fact, no one on scene claimed ownership of the magazine. Further inspection of the rifle revealed that the barrel was less than 16 inches. Additionally, the rifle barrel was threaded, with an attached flash suppressor. Further inspection revealed a detachable magazine, and pistol grip as well as a collapsable brace attached to the rifle. The semi-automatic rifle, having the ability to accept detachable magazines, exceeding the number of allowable modifications (2).
