Purpose: This Affidavit/Certification is to more fully describe the facts of the alleged offense so that a judge or authorized judicial officer may determine probable cause.

1. Description of relevant facts and circumstances which support probable cause that (1) the offense(s) was committed and (2) the defendant is the one who committed it:
On July 24th, 2024, at approximately 1214 hours, a white male wearing black pants, a grey hooded sweatshirt, yellow gloves, a white face mask who was holding an opened umbrella wearing white distinctive sneakers walked into the Santander Bank located at 17 Beaverson Boulevard in Brick Township New Jersey 08723. This individual approached the front counter of the bank and requested money to be placed into a plastic bag which was a multi colored Stop and Shop bag. The suspect retrieved a large amount of assorted US currency, fled the scene and was last seen running towards the wooded area in the area of Lions Head Blvd (a 55 and older community in Brick). Numerous police officers began a canvas of the area as well as K9 tracks leading to the area of the border of Lakewood and Brick which is between lake Rivera middle school and leisure village east (a 55 and older community in Lakewood). The K9 tracks ended at that area at the border leading towards that community in Lakewood. A canvas was conducted, and officers located a white mask, a black umbrella, a black replica handgun with black duct taped wrapped around it all in the woods/trails of the area of lake Rivera middle school which has a large number of woods and trails. Area residents contacted brick police stating they observed a male matching that description of the suspect. The conclusion of this investigation led to the approval of a search warrant for a residence at 1174d Clydebank Court in Lakewood. Search warrant revealed-Assorted us currency, and several items of clothing matching the suspect and gloves.
