Target Loss prevention contacted Brick Police Department stating their employee, Makayla Mincey, stole \$617.02 from Target. Mincey returned merchandise converting it into store credit and transferred the credit into store gift cards for her own profit. Video surveillance shows defendant scanning higher priced items with lesser value price tags through Target's self-checkout. Resulting in Target being deprived of a total value 60.00. Target surveillance shows defendant concealing Target merchandise with the intent to deprive Target of \$57.49. Target loss prevention provided me with surveillance video of the theft.
