Purpose: This Affidavit/Certification is to more fully describe the facts of the alleged offense so that a judge or authorized judicial officer may determine probable cause.

1. Description of relevant facts and circumstances which support probable cause that (1) the offense(s) was committed and (2) the defendant is the one who committed it:
During routine patrol, Officer Daniel Welsh #189 observed New Jersey Registration idling on Beach Way with three occupants in the rear passenger seat. During the course of the patrol investigation, it was determined that the three occupants were Nathan Cohen and two juveniles females (EC and MY) both of which were thirteen (13) years of age. During his initial approach to the vehicle, Officer Welsh reported that all occupants made furtive movements when they observed his presence specifically by moving away from each other in a manner that would be consistent with inappropriate activities. All occupants were removed and subsequently transported back to headquarters. During a formal taped interview with Cohen he admitted, after waiving his Miranda rights multiple times, that he had picked the two juvenile's victims up and transported them to Sea Bright. He then engaged in an act of aggravated criminal sexual contact by touching the breast of one of the juvenile victims (EC) over her clothing at which time Officer Welsh arrived.
