Purpose: This Affidavit/Certification is to more fully describe the facts of the alleged offense so that a judge or authorized judicial officer may determine probable cause.

1. Description of relevant facts and circumstances which support probable cause that (1) the offense(s) was committed and (2) the defendant is the one who committed it:
On Saturday 2/13/21 at 1540 hrs. I was notified by Dsg. Fusaro to investigate a sexual assault that was initially reported to the MPD Watch Commander. The caller reported that her daughter was sexually assaulted [REDACTED]. The caller was identified as the victim's mother, [REDACTED]. The victim was identified as [REDACTED]. The suspect was identified as [REDACTED], Felix Serrano. It was reported that incidents of sexual assaults occurred in 2019 when [REDACTED] lived with the suspect in Manchester, NJ.

On Tuesday 2/16/21 victim/witness interviews were conducted at OCPD SVU. During the course of the interviews, [REDACTED] disclosed that she was sexually assaulted in 2019, specifically by the suspect performing cunnilingus and putting his mouth on her breast in 2019.

A consensual intercept was conducted between the juvenile victim and the suspect. During the course of the consensual intercept, the suspect made admissions to sexually assaulting the victim, [REDACTED]

1. Description of relevant facts and circumstances which support probable cause that (1) the offense(s) was committed and (2) the defendant is the one who committed it:

On February 15, 2021, the Ocean County Prosecutor's Office, Special Victims Unit was contacted by Det. Richard Conklin from the Manchester Township Police Department in reference to a sexual assault that occurred in their town. Det. Conklin advised that one of the victim's [REDACTED] was also sexually assaulted in Jackson Township. Conklin advised that the suspect [REDACTED] identified as Felix Serrano, who she no longer resides with. On February 16, 2021, [REDACTED] responded to the Ocean County Prosecutor's Office, Special Victims Unit to provide a recorded statement. During her statement, she advised that when she was approximately 5-6 years old, she lived in a townhouse in Jackson Township, NJ with her mother and Felix Serrano. [REDACTED] stated that her mother worked overnights and Felix Serrano would watch her. During that time, [REDACTED] recalled several assaults in which, Felix Serrano, had her get on top of him, and touched her vagina by rubbing it with his hands and penis. He would also touch her breast area with his hands. While residing at [REDACTED] recalled the assaults occurring almost every night. [REDACTED] stated that sometimes she would be clothed and other times she would be naked. Felix Serrano would always take her underwear off. [REDACTED] also recalled while living at [REDACTED] that Felix Serrano touched her breast area and buttocks over the clothing. [REDACTED] also recalled sometime before middle school, sleeping in Felix Serrano's mother's bed, in Lakewood, NJ. She advised that Felix Serrano touched her chest area and vagina over the clothing with his hands. [REDACTED] advised that the assaults stopped when she was approximately 12 years old.
