Purpose: This Affidavit/Certification is to more fully describe the facts of the alleged offense so that a judge or authorized judicial officer may determine probable cause.

1. Description of relevant facts and circumstances which support probable cause that (1) the offense(s) was committed and (2) the defendant is the one who committed it:

Brick Twp Police Dept. patrol responded to Manasquan Bank (24 Princeton Ave) in reference to the defendant attempting to cash a fraudulent check. Bank staff inspected the check and determined it was not a real check and fraudulent. Manasquan Bank reported the defendant attempted to cash a similar check at two (2) Manasquan Bank locations (Howell - Successful, Manahawkin - unsuccessful). Once the defendant attempted to cash the check and bank staff recognized the check was fraudulent, the defendant quickly grabbed the check and left the location. Bank provided surveillance photos and a copy of the check and defendants ID. The check fraudulently produced read a company name at the top of 'JS PRO LLC' check number 1220 in the amount of \$1,292.31 made out to Arnaldo Vargas. This check number matches the check used at the Manahawkin location of Manasquan Bank.
