Purpose: This Affidavit/Certification is to more fully describe the facts of the alleged offense so that a judge or authorized judicial officer may determine probable cause.

1. Description of relevant facts and circumstances which support probable cause that (1) the offense(s) was committed and (2) the defendant is the one who committed it:

While on patrol of the Garden State Parkway in Toms River Township, Ocean County, I responded to an attempt to locate of a U-Haul box truck traveling Northbound. The caller, later identified as Ryan Donnelly, stated to 911 dispatch he was being kidnapped by the driver of the U-Haul. I located the vehicle traveling Northbound on the Garden State Parkway and conducted a motor vehicle stop at milepost 84.9, Toms River Township, Ocean County. Upon approach, I instructed both occupants of the passenger compartment out for further investigation. Upon opening the box compartment of the U-Haul I observed multiple mattresses on the floor as well as two adult males and two juveniles. One of the adults in the rear was confirmed to been the caller and requested medical attention on scene for a minor head injury. Both children appeared in disarray and neglected in the rear of the box container. The driver was subsequently arrested, handcuffed, searched, read his Miranda rights and placed in the rear of the Troop car. The driver claimed to be the father of both juveniles. Both juveniles, the female passenger and one male passenger from the rear were transported to the Galloway Station. The adult victim Donnelly was transported to the Ocean Medical Center for further medical treatment. He was treated and transported to the Galloway Station. At the Galloway Station all parties provided post Miranda interviews in regards to the incident. In summary, the driver, identified as John Williams, rented the U-Haul in NY on 02/26/2021 and traveled on the Garden State Parkway, with the passengers in the rear box portion, to Atlantic City, NJ. Upon leaving Atlantic City, the group again traveled on the GSP with both juveniles and two adults in the rear box portion. Donnelly attempted to exit the rear of the box portion, but Williams refused to open the box portion, denying Donnelly exit. The truck continued to travel on the GSP until being stopped by NJ Troopers. At the Galloway Station, DCP&P was contacted and responded to conduct interviews of all parties regarding the children. DCP&P took temporary custody of both juveniles at the Galloway Station pending further review.
