On 5/20/21, the property of [REDACTED] was sold by CitiMortgage to John Paitakis. Following the sale, the previous resident, Michael Tornillo, did not leave the residence. Paitakis filed for an ejectment and Tornillo was ordered to remove himself from the residence by January 31, 2021. On February 1, 2021, Paitakis took possession of the residence to find it had been severely damaged. An inspection of [REDACTED] was completed by Royal Restoration, and a repair estimate for the damages totaled \$111,799.24.
