Purpose: This Affidavit/Certification is to more fully describe the facts of the alleged offense so that a judge or authorized judicial officer may determine probable cause.

1. Description of relevant facts and circumstances which support probable cause that (1) the offense(s) was committed and (2) the defendant is the one who committed it:

On March 10, 2021, members of the OCNSF and Stafford DEU were conducting an ongoing narcotics investigation into suspect. Suspect traveled in his vehicle that had a search warrant had been previously received for. Suspect and his girlfriend were located standing outside of his vehicle initially by Det. Sgro of OCNSF. Suspect was verbally advised of the ongoing investigation and search warrant for his vehicle. Suspect immediately became verbally combative with Det. Sgro and began obstructing his investigation by not letting Det. Sgro pat him down and attempting to leave the area. Det. Sgro attempted to detain suspect by placing him in handcuffs until other officers arrived on scene. Suspect then pulled away from Det. Sgro and became physically combative. Suspect also bladed his body and assumed the fighting stance in an attempt to fight Det. Sgro. Suspect began flailing his arms, pushing away from Det. Sgro and attempting to grab onto other officers who arrived to assist. Suspect was advised to stop resisting and that he was being placed under arrest, and ultimately he would not stop resisting when he and other officers fell to the ground. Suspect would not give his hands to officers and continued to resist arrest for several minutes. Suspect was ultimately placed securely under arrest.

Subsequent search warrants were executed on suspect's vehicle, storage facility and hotel room. Located at these search warrant executions was sixty four (64) bricks (50 wax folds each) of suspect heroin, nineteen (19) grams of suspect cocaine, and two hundred (200) grams of MDMA (Ecstasy). Additionally, two (2) handguns were located including: a .40 caliber black Smith and Wesson and a 9mm black and orange FMK. The magazines on the handgun contained a 15 round capacity magazine.
