Appendix A

On March 31, 2021 a juvenile female [REDACTED] reported to the Lakewood Police Department Patrol Division that she had been the victim of an attempted luring and sexual assault. The victim indicated that a male, unknown to her had approached her while she was seated on a retaining wall in the area of her apartment within the High Point Apartment Complex. The male identified himself as "Julio" and provided her with a phone number for texting and communication purposes. The victim then dialed the number using the *67 option to conceal her phone number from him but noted that the phone began ringing in her presence after she dialed. Julio then began offering her money to go with him into his car and engage in forms of sexual activity. She declined repeatedly and he raised the amount offered in an attempt to get her to go with him into the vehicle and allow him to touch her "beautiful parts" and that no one would be able to see them. While this conversation was occurring, the victim was able to video record the incident using her cellular phone.

Upon receiving this case assignment an audio and video record of her statement was gathered at Lakewood Police Headquarters. During the statement the victim provided the same information also telling me that she had informed the suspect that she was a juvenile and repeatedly declined his offers to go with her. The victim also provided a view of the video record of the incident and allowed a copy of said video to be sent to me. Also sent was a screen shot from the video of the suspect.

After gathering the statement, I used several internet based search engines to attempt to locate owner/operator information for the cellular phone number provided by the victim. During said searches a name of "GR GOMEZ-HERRERA" was located using spydialer.com. This name was searched through the Spillman Computer Database used by the Lakewood Police Department and a name of Greissy Gomez-Herrera was located with an address of [REDACTED]. In addition to this a search using the Thomson-Rueters CLEAR database was conducted and determined that the cellular phone number was operated by the T-Mobile Corporation and a subpoena was generated requesting certain information regarding the owner/operator of the cellular phone number was generated. An APB Net Trak Flyer was also created using information from the report and the screenshot of the suspect to request assistance for identification purposes from law enforcement and other agencies.

It was determined that the video of the suspect was also posted on Facebook.com by an unknown person and information began coming to the Lakewood Police Department through different posts in the public areas of the video posting regarding the suspect, such as his screen name "Julio Anchia" and even pictures of his vehicle and house. Review of the Facebook.com account registered to Julio Anchia show a male with a face that is identical to that of the suspect in the video. Also on this account were photos of his wife, Greissy and he at their residence, located at [REDACTED]

It was also learned that the children shared by Julio and Greissy attend the Ocean County Academy Charter School and a subpoena request was generated for the information of the children that attend the school. The subpoena was issued and provided to administration at the school and two children [REDACTED]

Members of the Lakewood Police Department Detective Bureau responded to the address of [REDACTED] to attempt to locate the suspect on April 7, 2021 and again on April 9, 2021. He was not present at the address however several vehicles registered to Greissy Gomez-Herrera were located in the rear parking area of the residence. The resident of this address was spoken to and determined to be Greissy Gomez-Herrera. Greissy indicated that she is the husband of Julio Anchias and provided a birthdate of [REDACTED]. She also provided that he had spoken to her regarding the incident indicating that it was him in the video but claimed innocence. She also stated that he was hiding for fear of harm due to the posts she read and threats she and he had received on their Facebook accounts. It was requested that he contact the Lakewood Police Department however as of this writing he has made no contact with the Lakewood Police Department.

I received a telephone call from a male who stated his name was Andreas on April 10, 2021 and that he was close friends of Julio. He informed me that Julio was afraid to come to the police department because of the threats of harm he received and that he did not want to be deported due to his involvement in the incident. He also related that Julio had claimed innocence to him. Again it was requested that he speak to someone from the Lakewood Police Department and his location was requested. Andreas refused to provide a location for Julio.

There have been repeated attempts to speak with Julio regarding the incident however as of this writing no contact with him has been made.
