Purpose: This Affidavit/Certification is to more fully describe the facts of the alleged offense so that a judge or authorized judicial officer may determine probable cause.

1. Description of relevant facts and circumstances which support probable cause that (1) the offense(s) was committed and (2) the defendant is the one who committed it:

On April 17th 2021 at approximately 1909 hours, Officers McAvoy and Rusk were investigating a disturbance incident involving the defendant at the residence of 5 Lisa Robyn Circle Apartment 207, Lakewood, New Jersey. Officers McAvoy and Rusk attempted to make contact with the defendant while in his bedroom, specifically by knocking on his closed bedroom door and announcing themselves as Police Officers. Shortly thereafter, the defendant opened his bedroom door with a large, approximate ten inch fixed blade Katana style knife in hand. The defendant then began attacking Officers McAvoy and Rusk by striking both with said weapon. More specifically, the defendant struck Officer McAvoy in his facial area near his lip/ jawline, and struck Officer Rusk on the top of his head and in his forearm. The defendant's assault caused said officers to retreat for fear of their lives. Officer Seehausen (who was now on scene) drew his duty weapon and began giving commands to the defendant, which he disregarded and ultimately barricaded himself within the residence. Officers McAvoy and Rusk were then transported to Monmouth Medical Center Southern Campus, due to substantial lacerations sustained from the assault. The assault resulted in serious bodily injury to both officers,

[REDACTED] A perimeter was ultimately established, and the Lakewood Police Department's Special Response Team/ negotiators arrived on scene. After all efforts were exhausted to promote the defendant to surrender, the LPD Special Response Team made a tactical entry into the residence. While in the residence, Officer Nickerson was stationed at the stairway leading to the second floor of the apartment, where the defendant was located at the time. While stationed in the stairway, the defendant remained behind a wall but displayed a gold and black BB gun, which resembled a Glock handgun, in the stairwell and began shooting said BB gun down the stairwell towards Officers. This resulted in Officer Nickerson being struck with a metal BB fired from said firearm. Ultimately, the defendant was taken into custody without further incident in his bedroom on the second floor. While being secured, Sgt. Chase Messer of the Special Response Team recovered the aforementioned BB gun as well as the approximate ten inch fixed blade Katana Style knife
