The Defendant and the victim had a verbal argument . During the argument the defendant grabbed a knife. The victim then attempted to grab the knife from her. During the struggle for the knife the defendant grabbed a rubber ended mallet hammer and struck the victim over the back of the head. The victim had a visible sign of injury consisting of a small laceration, redness and swelling.
