ON 4/15/21 THE VICTIM, [REDACTED], RESPONDED TO HEADQUARTERS TO REPORT ACCOUNTS OF DOMESTIC VIOLENCE AGAINST HIM BY HIS GIRLFRIEND LORI ROLAND.
