1. Description of relevant facts and circumstances which support probable cause that (1) the offense(s) was committed and (2) the defendant is the one who committed it:

On 3/31/21, I contacted Det. Lindsay Most from the OCPO SVU, in reference to a report of sexual assault. I advised Det. Most that the victim, [REDACTED] [REDACTED] called the BTPD to report that [REDACTED] identified as Angel Gonzalez had sexually assaulted her when she was approximately 9 years old and ended when she was approximately 17 years old. [REDACTED] reported that Gonzalez had digitally penetrated her vagina, touched her breasts, put his mouth on her breasts, and performed cunnilingus on her numerous times as well as had her masturbate him. I advised Det. Most that [REDACTED] now resided in [REDACTED] but would be back in NJ in approximately two weeks to help her younger sister obtain her belongings to move with her to [REDACTED]. On 4/12/21, I contacted Det. Most and advised her that [REDACTED] would be arriving in NJ that evening, and would be available the following day. On 4/13/21, Det. Most and I met with [REDACTED] at the OCPO, SVU and conducted a taped statement of the victim. The victim advised that she resided at [REDACTED] in [REDACTED] with her mother, identified as [REDACTED] Gonzalez, her sister identified as [REDACTED], and her twin half-siblings identified as [REDACTED] and [REDACTED]. When the victim was approximately 9 years old, she recalled the first time Gonzalez sexually assaulted her. Her mother was working and Gonzalez was at home with her and her siblings. She stated that Gonzalez began tickling her in the living room of their residence and then began to touch her over the clothing on her breasts and vagina. He then asked her if she liked it and then told her not to tell anyone. [REDACTED] recalled that the abuse began to escalate and that Gonzalez would play hide and seek with her throughout the house. When he would find her, she stated that he would put her on her mother's bed and take her clothing off. She stated that he then digitally penetrated her and touched her breasts. She stated this continued to happen and she began to try to hide better so it would not happen or lock herself in the bathroom. [REDACTED] stated that at some point, Gonzalez began to touch her at night. [REDACTED] advised that her mother was sick throughout her life and was on multiple medications causing her to sleep throughout the night. She stated that Gonzalez would come into her bedroom using a flashlight and would digitally penetrate her, touch her breasts, and have her masturbate him.

█████ stated she broke her own bedroom door down in hopes that without a door, someone would see what was occurring.

According to the victim, her bedroom was moved upstairs when the twins could no longer share a bedroom. She recalled Gonzalez continuing to enter her bedroom at night with a flash light and digitally penetrating her, performing cunnilingus on her, and touching her breasts. She stated that as long as the sexual abuse was only happening to her and not her siblings, she would continue to deal with it. When █████ was approximately 17 years old, she stated that she went to live with her grandmother and that Gonzalez no longer had the opportunity to sexually assault her. During a visit with a therapist, she stated that she disclosed what had happened and afterwards went to tell her mother. Once back at the residence her mother confronted Gonzalez who admitted to what had occurred.

Years later, █████ told █████ that it had come out during a family argument, and that their mother had told them and that Gonzalez had admitted to it. She stated that she has asked her siblings if Gonzalez had touched or done anything to them, but they have all denied anything occurring.

During █████ interview, she disclosed that she had video recorded a conversation between Gonzalez and █████ as well as with █████ with their permission on her cellular phone while at her residence in █████. During the conversation Gonzalez made admissions about "touching" █████ more than once.
