1. Description of relevant facts and circumstances which support probable cause that (1) the offense(s) was committed and (2) the defendant is the one who committed it:

THE DEFENDANT SC WAS OBSERVED BY COSTCO LOSS PREVENTION STAFF OPEN BOXES USING HIS POCKET KNIFE AND PROCEED TO PLACE HIGHER PRICED ITEMS WITHIN. LOSS PREVENTION CONTINUED TO OBSERVE THE DEFENDANT SC THEN PROCEED TO BYPASS THE POINT OF PAYMENT WITHOUT PAYING FOR THE HIGHER PRICED ITEMS. LOSS PREVENTION STOPPED THE DEFENDANT OUTSIDE THE BUILDING AND ESCORTED HIM INTO THE LOSS PREVENTION OFFICE TO AWAIT POLICE ARRIVAL. I AM THE INVESTIGATING OFFICER. THE DEFENDANT SC ADVISED HE "FUCKED UP" WHEN QUESTIONED ABOUT THE INCIDENT AFTER BEING READ HIS MIRANDA RIGHTS AND STATING HE UNDERSTOOD THOSE RIGHTS.
