Purpose: This Affidavit/Certification is to more fully describe the facts of the alleged offense so that a judge or authorized judicial officer may determine probable cause.

1. Description of relevant facts and circumstances which support probable cause that (1) the offense(s) was committed and (2) the defendant is the one who committed it:

On 05/01/2021 at approximately 0230 hours I responded the area of [REDACTED] for a fight in progress. Dispatch relayed to other units that there were multiple subjects fighting in the street in front of the residence. Upon my arrival, dispatch advised that there were multiple subjects running across backyards behind the residence. I observed several subjects running behind the neighbor's residence to which I pursued the subjects on foot and observed two male subjects holding another male subject, identified as the defendant. The defendant was placed into handcuffs for safety because he was being non-compliant. On scene investigation concluded, that the defendant entered the victims residence through an unlocked exterior door. The defendant was found inside the residence and then removed because he was not wanted there. In front of the residence the defendant smashed the front glass pane door with his skateboard and the victims inside the house confronted the defendant on the front lawn. The defendant then struck the victim (F.C.) in the head and pushed him to the ground causing a minor laceration to his left elbow. The defendant also struck the victim (J.O.) in the face resulting in a complaint of head pain. While attempting to secure the defendant inside the patrol vehicle, the defendant physically resisted officers by stiffing his legs on the exterior frame of the door preventing officers from placing him inside the patrol vehicle.
