Purpose: This Affidavit/Certification is to more fully describe the facts of the alleged offense so that a judge or authorized judicial officer may determine probable cause.

1. Description of relevant facts and circumstances which support probable cause that (1) the offense(s) was committed and (2) the defendant is the one who committed it:

On 01/29/2020 Alexis Davis, who stated the following: at approximately 1300 hrs her boyfriend, Caron Atkins, asked her to go with her to pawn some jewelry. Davis found this a bit suspicious since all the jewelry Atkins owns is fake, and has no value. Davis and Atkins went to Ocean County Gold and Diamond Buyers (732-608-0099), 228 Brick Boulevard, where Atkins went in and pawned jewelry. Still suspicious of who the jewelry was pawned belonged to, she contacted her mother Lorraine Levine, who both her and Atkins reside with, to check her jewelry and make sure nothing was missing. After leaving the pawn shop Atkins and Davis left and began to travel south on Brick Boulevard. While in the car they began to argue about where he got the jewelry from. While on Hooper Avenue, in Toms River, between Yorktowne Boulevard and Church Road Atkins struck Davis in the face, giving her a black eye to her right eye. Davis refused medical attention.

Levine who stated the following: after Davis contacted her about the jewelry she responded to her bedroom and checked her Vanity where she kept her jewelry. Levine noticed she was missing a gold necklace, that was soldered together with a bracelet in order to make it longer. The necklace had a gold cross on it. Davis stated she regularly wears the necklace since it was a gift from her boyfriend 20 years ago and would have noticed it missing sooner. Davis valued the necklace at \$900 and the charm to be worth \$400.

I checked the RAPID Pawn System and located the transaction. I also spoke with the store owner Alan Spencer and he said he still had the jewelry. I responded to the store and recovered the items.

I also called and spoke with Caron Atkins several times over several days. He stated he did sell the items, using his identification but would not tell me who actually gave him the items. He stated he would pay the store back the money, but as of 2/13/2020, he has not paid the store back.
