After smashing the window with the rock, the defendant committed burglary by crawling through said window that was smashed out thus making unlawful entry into the apartment. Upon making unlawful entry into the apartment, the defendant ran to the victim's bedroom where the victim currently was inside said bedroom. The defendant then kicked open the bedroom door at which point he grabbed hold of the victim's arm and proceeded to strike her in the face multiple times with an open hand.

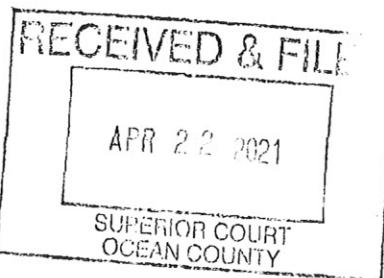
