ON 4/19/21, THE VICTIM REPORTED A FRAUDULANT CREDIT CARD CHARGE ON HIS WALMART BRANDED CAPITAL ONE CARD [REDACTED] IN THE AMOUNT OF \$422.24. THE CHARGE WAS COMPLETED ON 4/17/21 VIA THE WALMART.COM WEBSITE FOR ONE (1) NINTENDO SWITCH VIDEO GAME CONSOLE AND ONE (1) APPLE AIRPODS. THE VICTIM RECIEVED A CONFIRMATION EMAIL FROM WALMART.COM ADDRESSED TO JESUS PENUELA THAT HIS MERCHANDISE WAS READY FOR PICKUP. ON 4/17/21 THE DEFEDANT RESPONDED TO WALMART IN HOWELL TOWNSHIP (4900 ROUTE 9, HOWELL, NJ) AND PICKED UP SAID MERCHANDISE THEN LEAVING THE STORE. WALMART VIDEO SURVILLANCE WAS OBTAINED WHICH SHOWS THE DEFENDANT PICKING UP SAID MERCHANDISE AND LEAVING THE STORE. WALAMRT PROVIDED A DETAILED RECIEPT OF THE TAKEN MERCHANDISE TOTALING \$422.24. ON 05/06/2021, A PICTURE OF THE SUSPECT WAS POSTED ON THE BRICK TOWNSHIP POLICE DEPARTMENT FACEBOOK PAGE IN AN ATTEMPT TO IDENTIFY. ON 05/06/2021, THE DEFENDANT RESPONDED TO BRICK POLICE HEADQUARTERS WITH HIS MOTHER, ALEJANDRA MORALES, WHO STATED HER SON WAS THE SUBJECT DEPICTED IN THE FACEBOOK POST.
