Purpose: This Affidavit/Certification is to more fully describe the facts of the alleged offense so that a judge or authorized judicial officer may determine probable cause.

1. Description of relevant facts and circumstances which support probable cause that (1) the offense(s) was committed and (2) the defendant is the one who committed it:

On 03/19/2020 at approximately 1949 hours, units responded to the area of Route 88 and Route 70 in reference to a male subject who was reported stealing the caller's wallet from his vehicle. Upon my arrival, I met with the victim who stated, while he was at his place of employment at [REDACTED], he was approached by a white male subject, in his twenties, with short brown hair, wearing a gray sweatshirt, blue jeans and work boots. The victim stated that the suspect asked him for a ride to Point Pleasant and when he said no, the suspect walked away. The victim then checked his vehicle which was parked and unlocked in the parking lot. While checking his vehicle he observed his bifold wallet was opened on the front passenger seat and there was cigarette ash on the seat. The victim then attempted to locate the suspect and began driving West on Route 88, where he observed the suspect walking across Route 88 near 7-11. The victim stated he approached the suspect and confronted him near the partition of Route 88 and the parking lot of 7-11, when the suspect threw several cards which belonged to him and then ran across Route 70, near the Rainbow Diner. While units were checking the area, Ptl. Gordon #297 located a male subject matching the description, walking away from the Rainbow Diner, West on Route 70 EB. The suspect was subsequently detained by Ptl. Gordon and brought to the parking lot of the Rainbow Diner. The victim was transported to the area of the Rainbow Diner where I conducted a show-up. The victim was advised of show-up procedures and during which time the victim gave a positive identification of the suspect. The suspect was then placed under arrest and transported to Police Headquarters. Before speaking with the defendant at Police HQ, he was advised of his Miranda Rights and agreed to answer questions. I first asked him about the incident when he stated he was released from Ocean Medical Center and he did not have a ride home. He stated he pulled on the victim vehicle handle and entered it to see if he could find money for a ride home. The defendant stated he took the credit cards to attempt to pay for a ride home.
