Purpose: This Affidavit/Certification is to more fully describe the facts of the alleged offense so that a judge or authorized judicial officer may determine probable cause.

1. Description of relevant facts and circumstances which support probable cause that (1) the offense(s) was committed and (2) the defendant is the one who committed it:

The victim had purchased the residence at [REDACTED] from the defendants ex-wife in February of 2021 and was renovating it for resale which is currently pending. A call from a neighbor stating that they noticed a former owner Karl Scheufler parked in the driveway and walk around back of the house. They said a vehicle described as a light colored Cadillac CTS bearing NJ Reg. [REDACTED] leave a short time later. After the victim responded, he found that all of the locks to the house had been changed, new food in the kitchen cabinets, dirty clothes in a bedroom and personal hygiene products in the bathroom and it appeared as the shower had been used and someone was actually staying in the house. The victim also found paperwork on the counter to Cease and Desist Order for Trespassing. The victim stated that he recognized this paperwork from an incident where his wife was served the same at their home in Seaside.

In reviewing this paperwork, it is sent by a Karl House of Isreal from the new Hierusalem, Kingdom of Heauen. I immediately recognized this type of paperwork from past encounters with defendant Karl Scheufler who has sent me this type of paperwork with the same writings and headings referring to himself in this manner. I am also aware that Karl was a former owner of the residence at [REDACTED] before losing it in divorce proceedings with his ex-wife and has been involved in similar incidents in the past.
