Purpose: This Affidavit/Certification is to more fully describe the facts of the alleged offense so that a judge or authorized judicial officer may determine probable cause.

1. Description of relevant facts and circumstances which support probable cause that (1) the offense(s) was committed and (2) the defendant is the one who committed it:

During the month of April and May 2020, the Brick Township PD investigated seven (7) commercial burglaries. During the investigation, probable cause was developed believe the defendant committed several of those burglaries. During the investigation, the defendant has been observed by patrol officers and detectives in the area of Cedar Garden Apartments. Detectives observed the defendant enter the lower apartment at [REDACTED] over a period of several days. The defendant was observed wearing green/gray pants, gray shoes with white sole, and black mask. Detectives also observed the defendant wearing a black sweatshirt from Eastern Shore HVAC. The defendant is a white male approx. 6'0 thin with slight facial hair. Through previous police related investigation, the defendant was identified as Ryan Dautorio [REDACTED]. On 5/21/2020 at approx. 2130 hours, I began surveillance of Cedar Garden Apartments. My unmarked vehicle was positioned in the area of Plaza Terrace East near TD Bank monitoring pedestrian foot traffic. At approximately 2147, Brick Police Dispatch was contacted by the owner of Added Touch Florist (1021 Cedar Bridge Ave) advising of a glass break alarm. During the initial call taking procedures and dispatch gathering information, I observed a white male wearing a gray hooded sweatshirt and run on Plaza Terrace East. I turned on my headlights and positively identified the subject as Ryan Dautorio. The defendant ran toward the lower apartment at [REDACTED] and entered toward rear glass slider. I responded to Added Touch Florist where I observed the front glass door smashed with a landscape rock. Det. Puccio observed the defendant through the rear slider from a distance change out of his gray sweatshirt and green/gray pants into shorts and a black t-shirt. K-9 Sgt. Martucci of the Toms River Police Dept. arrived on scene and conducted a K-9. The K-9 track led a scent trail from the front of Added Touch Florist to the rear sliding door of [REDACTED]. Units maintained a perimeter of the residence. Ptl. Zurica was on location at Added Touch Florist and advised approx. \$78.00 in various denominations was removed from the register. Contact was made with Dautorio as he exited a short time later. Based on previous clothing the defendant was observed wearing in surveillance videos from 5/14 and 5/16, probable cause was developed to believe Dautorio is the suspect.
